**COMMITTEE: Aging** 

**TITLE:** To amend the administrative code of the City of New York, in relation to establishing a silver alert program to provide public notification for missing senior citizens with certain cognitive impairments.

SUMMARY OF LEGISLATION: The primary purpose of this Introduction would be to establish a targeted public notification mechanism similar to the "Amber Alert" system which targets missing and exploited children. The "Silver Alert" system would, however, issue public notifications of missing elderly persons with cognitive impairments such as Alzheimer's disease and are, therefore, in physical danger as a consequence. This legislation seeks to establish a protocol utilizing the existing "Notify NYC" public notification structure as well as the resources of emergency response agencies and first responders such as the NYPD, FDNY and OEM as well as agencies who deal directly with eldercare issues such as DFTA. It is likely that the bulk of the cost to implement this legislation would come at the "front-end" of the implementation process and involve mainly "start-up" costs. The fiscal impact of this process, however (as well as operating costs down the line), would likely be borne out of existing resources and would therefore be minimal to non-existent.

**EFFECTIVE DATE:** This local law would take effect ninety days after its enactment into law.
