CHAIPERSON DE LA ROSA: Thank you, and good morning, and welcome to the hearing of the city council's Committee on Civil Service and Labor. Today the Committee will vote on Resolution Number 24 of 2022, sponsored by Council Member, Crystal Hudson. Calling upon the State Legislature to pass and the Governor to sign the Fair Pay for Home Care Act. New York has a large need for home care, more then ever before. And at its censor, as a national home care workforce crisis. Vulnerable community members are going without home health services or becoming institutionalized because there not enough home care workers to meet the demands in New York state. A consulting firm, Mercer, estimates that despite the rapid growth potential, the state will face a

shortage of 80,000 home care workers by 2025. The primary reason is that homecare aides are among the lowest paid workers in the state, averaging \$22,000 annual earnings. The New York state's Senate's Aging Committee, issued a report that found out more then 1 in 7 no wage workers in New York city is a home care worker. 1 in 4 home care workers live below the federal poverty line and over half rely on Public Assistance. The Fair Pay for Home Care Act, would respond to this crisis by providing a fair and just wage to home care workers. State Senator Rachel May, and Assembly member, Richard Gottfried, introduced Senate Bill 5374-A and Assembly Bill 6329-A, entitled the Fair Pay for Home Care Act, to raise home care wages to 150% of the minimum wage, allowing home care workers to make at least \$35,000 a year on average. Thank you very much to the advocates and impacted individuals who brought their attention and testimony to these issues in helping shape this legislation, as well as my colleague, Council Member, Crystal Hudson, for this resolution. At this time, I'd like to turn to my colleague, Hudson, if she's on, to make a statement on Resolution 24 of 2022. Thank you.
