District on April 4th. This project was scheduled to

be voted on by the full Council at a Stated meeting on April 7th. However, due to the re-scheduling of the Stated meeting to April 14th, the statutory deadline for Council action as applicable to the project expired and pursuant to Section 197-D of the Charter, the application were deemed approved.

Notwithstanding the provisions of Charter Section 197-D Article 16 of the New York State, General Municipal Order requires... requires that the Council make factual findings related to the designation of the urban development action interview. Therefore, today we'll vote to approve a new Preconsidered Resolution related to the new Provi... Providence redevelopment that includes such findings as well as a legislative history of this action.

Today we'll vote to approve Preconsidered LU's 37 and 38 related to Our Lady of Pity, 272 East 151st

Street Rezoning Proposal, in my district in the Bronx. The proposal will rezone an existing R6 and R7A district and establish an MIH program area utilizing MIH actions one and two. These approvals will facilitate the development of a new 100 percent affordable nine-story building.
