Today we will vote to approve LU44, the Mount Nebo, Mount Caramel cemetery merger request submitted by Mount Caramel Cemetery pursuant to sections 1506C of the New York State non for profit corporate law. This application requests approval to merge the Mount Caramel Cemetery located at 83-55 Cyprus Hill Street block 3750 lot 655. With the Mount Nebo Cemetery located at 82-07

Cyprus Hill Street lot 3750, lot 705. The cemeteries are located in the Queens council district represented by council member Holden. We heard this application at our meeting on April 26th. We will also vote to approve pre-considerate LU34, the Second Avenue subway 125th Street disposition. This application was submitted by the metropolitan transit authority pursuant to the section 1266C of the New York State public authority's law requesting approval of the acquisition of city-owned property located at block 1773, lot 4 and 72 in the bureau of Manhattan to facilitate the northward extension of the Second Avenue subway and the construction of a station at 125th Street. The property is located in the council district represented by Deputy speaker Ayala. We heard that application on, on our meeting on April 4th. Council, please call the roll.
