5	New York City Council hearing of the Committee on
6	State and Federal Legislation. At this time will
7	council staff please turn on their video. Please
8	place electronic devices on vibrate or silent. Thank
9	you. Chair, we are ready to begin.
10	Chairperson Abreu: Trial begin. Good
11	morning everyone. I am Shaun Abreu, Chair to the
12	Committee on State and Federal Legislation. Thank you
13	for joining us for this morning's virtual vote. Today
14	we'll be voting on seven state legislative
15	resolutions also known as home rules or SLR's in
16	support of various state legislation. I'd like to
17	know take a moment to briefly go through the escolars
18	for everyone. S3259 is an act that would increase the
19	fine for a tractor trailer combinations that park on
20	residential streets overnight in an effort to deter
21	these large commercial vehicles from taking up
22	parking spots on residential streets for long periods
23	of time. S5602B would renew the authorization for the
24	city's speed camera program through July 1, 2025 and
25	would remove the restriction on operating the cameras
l

2	3 overnight and on weekends allowing them to operate
3	full-time. The legislation also requires signs
4	indicating that speed monitoring is active at camera
5	locations. The next SLR, S1608 would ensure that
6	consistent with the New York Constitution promotions
7	to supervisory roles in the department are made in
8	accordance with competitive examination to ensure
9	that the highest level of service is rendered to the
10	public in the most efficient and competent possible
11	manner. On the topic of pensions, we have S9125 which
12	amends the New York City administrative code in
13	relation to the pensionable earnings of first grade
14	police officers. Additionally, we are voting on S9237
15	an act to amend the retirement and social security
16	law to allow certain members of the New York City
17	Police pension fund to borrow from contributions.
18	Lastly, we have three SLR's in relation to improving
19	accessibility at public stations in New York City.
20	First, S9120A would authorize the city to discontinue
21	use some Bronx park land and to grant access for
22	improvements to the railroad bringing metro north
23	service to four new stations in the Bronx and to Penn
24	Station. Additionally, we are voting on S9323 and
25	S9068B which would make accessibility related
ļ

2	improvements at the Broad, Broadway junction and
3	168 <sup>th</sup> Street transit stations respectively. I'd like
4	to once again thank my colleagues for their advocacy
5	and engagement during this process. Thank you to the
6	members of the Committee on State and Federal
7	Legislation who have joined us today To vote on these
8	important home rule messages all of which stand to
9	improve the lives of New Yorkers across this great
10	city. I'd also like to thank Carlos Beato and
11	committee staff Jayasri Ganapathy, Wiam
12	Diouri, and Hector Helman (SP?). I'd also like
13	to thank my staff member Jalissa Quigley. I'd
14	like to now ask the clerk to call the vote.

18	coupled. Chair Abreu?
