

My name is Scout Silverstein and I am a born and raised NYC resident. Part of my experience is growing up in foster care and aging out in 2005, at 17 years old. I went from living in a group home in Pennsylvania to living in a 6 bed dorm at the block from the first syringe exchange led by Kelly McGowan and Chloe Dzubilo whose main participants were people living with HIV/AIDS, sex workers, unhoused people, and transgender people. Both my living quarters and this service were essential for the public health and well being of New Yorkers. Now, 17 years later, living in NYC is less affordable and less accessible. Our Mayor pushes for more policing and disinvestment from houseless services which is worsening our housing crisis. Housing is a human right and the council has the power to create sustainable infrastructure to support our most vulnerable residents. Hello, My name is Stephanie Schroeder and I live on the edge of Hell's Kitchen. I live in a luxury building I won through the NYC lottery. I need this rent stabilized, low-income rental because I work at a nonprofit agency in a low-paid job. Specifically, I work as a peer specialist at a homeless shelter in Manhattan. I can verify that homeless folks are people like you and me. People with have families, friends, and are also in distress. Distress from not having a place to live. I know it's easy to dismiss all homeless folks with a wide brush as violent predators, crazy people, drunks and junkies, and other things that in this society are negatives. In facts, people

living on the street are in grave danger and coming inside would help all of us. The homeless folks I know: clients, personal friends, extended family, are people who've experienced extreme trauma including eviction, rape, robbery, police violence, and so much more. These are our neighbors. Neighbors who are unhoused and in distress. Rent in NYC is exorbitant - too damn high as the saying goes! So are the numbers of people on the street. As I mentioned, I can only afford to live in NYC because I won the housing lottery. I've been in NYC 30+ years and was going to be priced out. I also live with a mental illness. You would never "know" this to look at me. Because I have a home. I have a place to shower, sleep, keep my clothes, fix meals, use the toilet, etc. We must welcome our homeless neighbors - already living in here Midtown, Hell's Kitchen, the Upper West Side, to join us in having homes - apartments of their own. It's the only humane decision.
