My name is Diana Ayala, and I am the Deputy Speaker of the New 16 17 York City Council and the Chair of the General 18 Welfare Committee. 19 Today, our Committee will vote on 20 legislation sponsored by Council Member Alexa Avilés 21 that I was proud to support, Intro 0303-2022, which 2.2 is a Local Law to amend the Administrative Code of 23 the City of New York in relation to requiring the 24 Department of Homeless Services and the Human 25 Services Administration to track and report certain

2 data regarding rental assistance programs. This bill 3 would require that DHS and HRA track and report 4 certain data regarding rental assistance programs 5 including outcomes of the City Fighting Homelessness and Eviction Prevention Program, which is also known 6 7 as CityFHEPs. This would include how long a household 8 languishes with a shopping letter for a voucher 9 without being able to use that voucher. In an effort to provide greater transparency in the process of 10 11 rental assistance programs, it is our hope that the 12 more we know the better we will be able to provide 13 programming assistance to meet the needs of those New Yorkers. 14 15 I'd like to thank the advocates, 16 providers, and those with lived experiences who 17 informed and helped shape this legislation.
