5	conducting a vote on two pieces of legislation
6	pertaining to animals. One sponsored by Council
7	Member Vallone, and the other, Council Member
8	Lappin. Lappin's proposed Introduction 328A would
9	raise the licensing fees for dogs that are not
10	spayed or neutered, and Council Member Vallone's
11	bill, Intro 425A, will prohibit the tethering of
12	animals for more than three hours in any
13	continuous twelve-hour period. I want to
14	congratulate my colleagues on their legislation
15	and Council Member Vallone for staying the course
16	on this legislation, I know he's been working on
17	it for, as I understand it, about four years. I
18	want to thank the Committee staff, in particular
19	Joe Mancino, who has been working really, really
20	hard to keep us together in the absence of an
21	assigned Committee counsel man, we have Phil Hom
22	with us filling in until we get a new counsel
23	assigned. I want to recognize my colleagues from
