Good morning,

I am writing as a resient and safe streets advocate to please beseech the NYC City Council land use committee to please refrain from approving a 2 story car dealership on Northern Boulevard. If you have not visited Northern Boulevard, it is full of car dealerships and often double parked by car carrier vehicles that load and unload causing serious danger to bicyclists and pedestrians. In the last few years, since Commissioner Trottenberg came in 2018 to announce safety changes to Northern Boulevard, biking has risen in the area. A new high school building, which will include 3 schools, one a special ed school...in those short years, the area has become more residential, and protected bike lane, a new H Mart and better transit have made the area more of the boulevard connecting Astoria and Sunnyside neighbors, rather than what Koeppel Dealerships have posted billboards claiming to own it. "Koeppel Blvd" In green is a 25 foot billboard there.

Since 2014 when 64 year old Kumar Ragunath was killed on Northern Blvd at 41st ave, advocacy for non vehicle residents has grown. That death, and many others in Queens were hit and run deaths, and have been unsolved. We simply can not have another dealership at a time of extreme housing crisis, overuse of vehicle traffic and a beyond threshold level of car dealerships already existing in that area. It's unacceptable and a very poor choice for Queens residents and constituents who are not given a choice.

I highly doubt that neighbors at 58th and Northern are being made aware of this growth.

I founded Make Queens Safer, an organization promoting advocacy for safe streets in the borough. To date, we have sadly hosted at least 5 vigils for children killed by traffic violence on Northern Boulevard. We simply can not bear to see vehicles take priority even whil blocks away, a schools structure is being built. Those children will be walking, biking and bussing to school. A car dealership is not a good environemnt for commuting students. This is a neighborhood.

Currently I work for the New York Coalition for Transportation Safety, a non-profit funded by the New York State Governor's Traffic Safety Board. Our aim is to reduce injury and death in the borough of Queens through outreach, advocacy, events and materials giveaways that will promote safe driving and road use. I am nearing a decade of advocacy on Northern Boulevard, which has included walk throughs with former council member Van Bramer, to fight back against dealership cars blocking sidewalks.

My name is Laura Shepard and I strongly oppose the ULURP application for a Lincoln dealership at 58-02 Northern Blvd and urge this committee to vote it down. I am a Woodside resident and member of Community Board 2 (though I'm speaking as an individual.)

This dealership is an illogical and ludicrous use of transit-accessible land that is currently zoned residential, amidst a housing crisis. In fact, CB2's land use committee has convened a taskforce to discuss specific requests for a broader rezoning for the entire corridor to prioritize affordable housing, local businesses, and green space. To date, alternative uses that would better serve community needs or create green jobs were not seriously considered for this site.

The applicant's business and products are inappropriate and no one is fooled by their attempts to greenwash or claims that this concept will be different. The applicant failed to identify an appropriately zoned lot, where they could proceed as of right and they are not entitled to expand the footprint of the auto industry in NYC, where the majority of residents do not drive and so many of us advocate for a dramatic reduction in the number and size of vehicles on our streets.

Western Queens has ample public transportation options and is striving to become more walkable and bikeable. However, we suffer from high rates of traffic violence and Northern Blvd is a Vision Zero priority corridor. Since Jan. 2015, 1,015 road users were injured and one killed on Northern Boulevard, west of the Brooklyn-Queens Expressway. Last April, 89-year old Yuitmay Szeto, was killed by an SUV driver while walking nearby, on 48th Street. East of the BQE several children and seniors were killed walking, including 19 year old Sara Perez, who was killed by a pickup truck driver on the Northern Boulevard sidewalk outside an auto business.

We cannot stem the tide of traffic violence by continuing to allocate land for auto businesses, which abuse our public space, by driving and parking on our sidewalks and bike lanes and bus stops, making it difficult and dangerous for pedestrians, cyclists, and transit users to traverse the area, while drivers continue to speed through.

Illegal parking is already the number one complaint category in Community Board 2, where existing auto businesses are historically bad neighbors. We have also observed that this

applicant operates his Jamaica dealership in a similar manner. SUVs are chronically parked and driven on the sidewalk, endangering pedestrians, many of whom are en route to the subway. The applicant should not be allowed this rezoning to expand while this continues.

The applicant also claims they cannot hold Lincoln accountable for their products. The current fleet of sport utility vehicles averages well under 30mpg and under 25mpg in cities, which will contribute unnecessary emissions and air pollution.

Their intent to convert to electric vehicles by 2030 is too slow and inadequate, given that there are currently 416ppm of CO2 in the atmosphere we are already feeling the impacts. Also, the emissions benefits of electric vehicles are largely obliterated by the excessive weights of these heavy SUVs and pose even greater danger to vulnerable road users.

Also, 13 of the 17 children killed in NYC in 2022 were killed by SUVs, pickup trucks, vans, or school buses.

58-02 Northern Blvd is one block from an elementary school, P.S.152 and several other neighborhood schools, including a yet to open 3,000 seat high school on 54th Street. Our neighbors, especially the children, deserve safe walks to school.

This rezoning will harm my neighbors and our city, with no meaningful benefits that could not be realized as of right or by another applicant for just about any other use. Please oppose the ULURP application for 58-02 Northern Blvd. My neighbors and I deserve a Green New Northern and a better future.
