Proposed Intro 124A will require reporting on and training of housing specialists in the Human Resources Administration and the Department of Homeless Services.

The second bill we are voting on is also sponsored by Council Member Salamanca and would require customer service training for shelter personnel of the Department of Homeless Services and its contractors.

Finally, the third bill that we are voting on, Proposed Intro 642A, sponsored by Council Member Nantasha Williams would require quarterly reporting on the amount of time children and youth spend in children center and other temporary placement facilities of the Administration for Children Services.
