On July 20, 2023, the Land Use Committee of the City Council, by a vote of 10-0-0 for Application C 210314 ZMK recommended modifications of the City Planning Commission's decision in the above-referenced matter.

The Zoning Resolution of the City of New York, effective as of December 15, 1961, and as subsequently amended, is further amended by changing the Zoning Map, Section No. 13b, changing from an M1-1 District to an M1-5 District property bounded by Flushing Avenue, <u>a line 170 feet southwesterly of</u> Wyckoff Avenue, Jefferson Street and a line 250 feet northeasterly of Irving Avenue, Borough of Brooklyn, Community District 4, as shown on a diagram (for illustrative purposes only) dated February 13, 2023, and subject to the conditions of CEQR Declaration E-674.
