









Location & Context





Project Overview

- One 10-story new construction building, classified as a Community Facility (NPISA)
- Proposed building will contain 4 duplex shared housing units (8 rooming units in each):
 - Approximately 32 total residential units, plus one building manager's unit
- 100% Supportive Housing development
 - Homeless youth referred by NYC HRA
 - Units restricted to households (individuals) earning up to 60% AMI
 - The Ali Forney Center will manage on-site supportive services
- Commitment to Local Hiring in collaboration with Local Workforce Development Training Programs for Laborers and MWBE subcontractors

Building Experience

- LGBTQ-affirming building aiming to provide support for formerly homeless youth
- Each duplex shared housing unit will contain:
 - One kitchen
 - Four ADA accessible bathrooms (two per floor)
 - · Laundry facilities
- Other building amenities include:
 - Multi-purpose gathering space
 - Work/study spaces
 - Accessible landscaped rear yard


Resiliency & Sustainability




