1 COMMITTEE ON SANITATION AND SOLID WASTE MANAGEMENT 2 2 SERGEANT-AT-ARMS: This is a microphone 3 check for the Committee on Sanitation and Solid Waste Management on December 20, 2023, by Layla Lynch. 4 5 SERGEANT-AT-ARMS: Good morning and 6 welcome to the Committee on Sanitation and Solid 7 Waste Management. 8 At this time, we ask that you please 9 place phones on vibrate or silent mode. 10 Chair, we are ready to begin. 11 CHAIRPERSON NURSE: [GAVEL] Good morning, 12 everyone. Welcome to the final vote for the Committee 13 on Sanitation and Solid Waste Management of the 14 session. Thank you to the Committee Members for being 15 here. The purpose of today's hearing, we're 16 17 going to have a vote on three key pieces of 18 legislation. These bills will help ensure that post 19 storm cleanup branches and trees is done in a prompt 20 manner, that our city's streets and waterways remain 21 free from hazardous cleaning fluids, and that we move closer to a meaningful reduction in plastic pollution 2.2 23 and bottles discarded as waste. 24 The bills we will be voting on today 25 include Intro. 145 sponsored by Council Member Justin

1 COMMITTEE ON SANITATION AND SOLID WASTE MANAGEMENT 3 2 Brannan in relation to requiring the Department of 3 Sanitation to remove fallen tree limbs, branches, and 4 vegetation that obstruct streets and sidewalks as a 5 result of severe weather; Intro. 1131 sponsored by Council Member Rafael Salamanca in relation to 6 7 outreach to unlicensed mobile carwash operators and authorizing seizure for certain mobile carwashes; and 8 9 finally, Intro. 1161 sponsored by Council Member Shaun Abreu in relation to allowing reusable beverage 10 11 containers in sports venues. I want to thank everyone on the team and 12 the Sanitation task force for their work on these 13 14 bills and their efforts in moving this Committee and 15 community forward over the past year. I'd like to 16 acknowledge Council Member Chi Ossé, Council Member 17 Kristin Richardson Jordan, Council Members Julie 18 Menin, Bottcher, Salamanca, and Farías as well as 19 Restler maybe is joining us. Are you on this 20 Committee? Oh, okay. I was like I'm acknowledging 21 you. Thanks for being here. 2.2 Council Member Salamanca, you're good?

23 Okay, let's do the vote. We're ready.

CHAIRPERSON NURSE: I'm going to recognize 5 Council Member Kalman Yeger. 6 7 COMMITTEE CLERK WILLIAM MARTIN: Council 8 Member Yeger. 9 COUNCIL MEMBER YEGER: Okay. May I be excused to explain my vote, please? 10 11 CHAIRPERSON NURSE: Of course. 12 COUNCIL MEMBER YEGER: Thank you very 13 much. I vote aye on all with the exception of 14 Introduction 1161, and I'd like to explain why. When 15 the original draft of the bill was introduced, it was 16 a bill that I could support. It was cognizant of the 17 environmental needs and it made sense to allow people 18 to use reusable containers, try to do a little better 19 for the environment. The changes in the amended 20 version of the bill, the one that is being adopted by 21 this Committee today, has inserted language that requires that the drinking vessel that we are 2.2 23 allowing in be composed primarily of aluminum or stainless steel. The first version of this bill did 24 25 not have that. It allowed it to be of any material.

2	The second change is that it requires that the
3	container be capable of holding up to 24 fluid
4	ounces. A stainless steel container capable of
5	holding up to 24 fluid ounces is basically a brick.
6	That's what we're talking about. We're talking about
7	allowing people to bring bricks into sports venues.
8	That's a public safety hazard in my opinion. I think
9	it's dangerous. I think it doesn't make sense. I
10	think we have to allow the hosts to make their own
11	determinations about the safety of their patrons. For
12	that reason, and that reason alone, it's not about
13	the environment because I would support the bill
14	otherwise, but for that reason alone, the safety of
15	the patrons at these sports facilities and what will
16	ultimately happen when somebody gets killed by
17	somebody hurling one of these things at their head, I
18	want to be able to say that I vote no, and I vote no.
19	Thank you very much.
20	CHAIRPERSON NURSE: Thank you, Council
21	Member.
22	COMMITTEE CLERK WILLIAM MARTIN: With a
23	vote of eight in the affirmative, zero in the
24	negative, and no abstentions, Introductions 145-A,
25	809-A, and 1139-A are adopted by the Committee, aAnd
