1 COMMITTEE ON CIVIL SERVICE AND LABOR 2 2 SERGEANT-AT-ARMS: This is a microphone 3 check for the Committee on Civil Service and Labor, 4 recorded on December 20, 2023, by Layla Lynch in the 5 Committee Room. 6 SERGEANT-AT-ARMS: Good afternoon, and 7 welcome to the Committee on Civil Service and Labor. 8 At this time, we ask that you please 9 place phones on vibrate or silent mode. Thank you. 10 Chair, we are ready to begin. 11 CHAIRPERSON DE LA ROSA: [GAVEL] Good 12 morning. Welcome to today's vote of the Civil Service 13 and Labor Committee. I am Committee Chair, Council 14 Member Carmen De La Rosa. 15 Today, the Committee will be voting on 16 Proposed Intro. 563-A sponsored by Council Member 17 Brewer in relation to creating a private right of 18 action to enforce provisions of the Earn Safe and 19 Sick Time Act. Under the current law, employees whose 20 safe and sick time rights have been violated are 21 limited to filing a complaint with the Department of 2.2 Consumer and Worker Protection. This bill would allow 23 employees who are alleging a violation of their 24 rights under the Earned Safe and Sick Time Act to 25 commence a civil action in court of competent

2	jurisdiction within two years from the date they knew
3	of the alleged violation. This remedy will be a
4	critical backstop to administrative enforcement for
5	cases that may be difficult and take a great deal of
6	agency time or in times when the agency may face a
7	particularly large caseload or cuts in the budget. A
8	private right of action for paid safe and sick leave
9	will promote deterrence and help to ensure more
10	workers are made whole when their rights are
11	violated. This bill supports New York City's workers
12	so that they can take care of themselves and their
13	families without risk to their economic security.
14	I'd like to thank our Committee Staff,
15	including Senior Policy Analyst Elizabeth Arzt,
16	Legislative Counsel Rie Ogasawara, and Finance
17	Analyst Andrew Lane-Lawless for their hard work in
18	preparing for this vote. I also want to extend my
19	thanks to my team including Chief of Staff James
20	Burke, Legislative Director Kiana Diaz, and
21	Communications Director Fray Familia.
22	I will now turn to Council Member Brewer
23	for her opening statement in support of the bill, and
24	I want to thank Council Member Brewer for her long-

2 time advocacy for earned and safe sick time for 3 workers in our city. Council Member Brewer.

4 COUNCIL MEMBER BREWER: Thank you very much, Madam Chair. I am really pleased to be able to 5 discuss 563-A. I am really, really pleased that the 6 7 Council is voting on legislation, as you have 8 indicated, to add a private right of action provision 9 to the Earned Safe and Sick Time Act. I call it paid sick time. Nearly two thirds of the paid sick time 10 11 laws across the country have a private right of action including the state of New York. Today's vote 12 coincides with the 10th anniversary of the passage of 13 the City's earned sick time law, which I introduced 14 15 and fought for alongside an incredible coalition many 16 years ago now it seems to guarantee paid time off for 17 3.4 million private sector workers across New York 18 including 1.2 million workers who at the time had no 19 access to paid sick time before the law passed in 20 2013, and thank goodness it did because the pandemic showed the need for it. It's a critical need, I 21 think, for private right of action. It's a short 2.2 23 list. When workers lose their jobs because they took protected sick time, equitable relief is much more 24 readily available in court. Workers who experience 25

2	paid sick time violations often have additional
3	claims including wage and hour violations. It is
4	easier to seek remedies for multiple types of
5	violations at the same time in a single court action.
6	Finally, a paid sick class action involving numerous
7	workers facing similar violations is only an option
8	in court. I hope these are reasons that are clear to
9	everyone for the need for 563-A.
10	I too want to thank several people. Shula
11	Warren-Puder, this bill would not have passed without
12	her. She was the main negotiator many years ago on
13	paid sick days and she was a negotiator on this
14	aspect of it, I want to thank her, and certainly Sam
15	Goldsmith from our office, Jeff Baker who also
16	contributed, and I also want to thank Rie Ogasawara
17	who put up with many, many, many phone calls from our
18	office, the Department of Consumer and Worker
19	Protection which really does care about workers.
20	Jeremy John, Faiza Ali, and also the Partnership and
21	the Hospitality Alliance. They're not ecstatic about
22	the law, but they worked with us, they made
23	suggestions, and we will continue to discuss the law
24	with them as time goes on, and also the amazing women
25	lawyers at A Better Balance.
