CHAIRPERSON FOSTER: Good morning, 3 I'm Helen Foster and I am Chair of State and 4 5 Federal Legislation. I'd like to introduce my Committee Members: Erik Dilan from Brooklyn, 6 Domenic Recchia from Brooklyn, Joel Rivera from The Bronx, and Liz Crowley from Queens. 9 legislation that is being considered was passed in the Council last year, and subsequently not passed 10 11 in Albany. The bill being considered today would 12 authorize the City of New York to discontinue the 13 use as parkland of parcels of real property in 14 Brooklyn for park purposes in furtherance of a 15 comprehensive development plan for Coney Island. 16 The two parcels would be utilized, would be 17 utilized currently operate, the two parcels that 18 would be utilized currently operate as the parking 19 facility for the Brooklyn Cyclone, a minor league 20 baseball team, and the indoor Abe Stark Staking 21 Rink in Coney Island.
