5	of the Zoning and Franchises Subcommittee and this

10	will read on number two on the mapping action it
11	establishes within an existing and proposed R3-1

14	1 District and C2-2 District bounded by a line.
15	It is going to be changed from 140 feet to 145
16	feet northerly on 11 th Avenue and 154 th Street, 11 th
17	Avenue and the line 135 feet easterly of 154 th
18	street, so the change of the modification is—

20	District, the modifying boundary line will go from
21	140 to 145 feet. With that, we are going to move
