Proposed Intro No. / Title: *Int. 1228 / Expanding the categories of businesses that may be subject to requirements regarding the disposal of commercial organic waste*

Sponsors: Abreu, Nurse, Rivera and Louis

Committee: Sanitation and Solid Waste Management

Summary of Legislation: This legislation expands the categories of businesses required to comply with regulations regarding the disposal of commercial organic waste to include catering establishments and sponsors of public events. It also updates the evaluation process by which the Department of Sanitation determines when such establishments must comply. The legislation additionally ties the compliance deadlines for added business categories to the implementation of commercial waste zones.
