2	CHAIRPERSON VACCA: Hello. Today
3	is December 15 th , 12 noon or thereabouts, and I
4	would like to call this meeting to order. I'm
5	James Vacca. I'm Chair of the City Council
6	Transportation Committee. I want to thank
7	everyone for coming to our second meeting hearing
8	on proposed Intro 567-A and the Committee will be
9	voting on this today to amend the Administrative
10	Code in relation to the requiring the Department
11	of Transportation to provide online access to
12	street resurfacing and capital improvement
13	information for city blocks. I want to thank and
14	commend Council Member Oddo for introducing and
15	advocating for this legislation. It's the latest
16	in a line of legislation coming from this
17	Committee to increase transparency of information
18	within the New York City Department of
19	Transportation. I'm a firm believer in having the
20	public have as much information as possible and
21	empowering communities and the public to have a
22	say in decision making that affects their daily
23	lives.
24	This bill continues that trend. It
25	would require DOT to have online through their

2	website the following information: the year the
3	street was last resurfaced and received capital
4	improvement, and the current rating of the road
5	either good, fair or poor. In addition, this
6	information will be required to be searchable by
7	block by January 31 st , 2013. This information will
8	enable communities to know what roads they should
9	focus on when deciding where in their neighborhood
10	street resurfacing projects should take place
11	based on need. Do any Council Members wish to be
12	heard on this item? Council Member Ignizio?
13	COUNCIL MEMBER IGNIZIO: Yes, thank
14	you Mr. Chairman. On behalf of my colleague,
15	Minority Leader Jimmy Oddo, I want to thank the
16	Committee along with my other colleagues for
17	taking this bill up. Jimmy worked very hard on
18	this bill with the Administration and with you and
19	we genuinely believe that this will go a long way
20	in not only in informing the public, but assuaging
21	them that there is not a political system what
22	which their streets get paved, but there is a
23	criteria what which they can check and they can
24	hold government accountable. I'm honored to be a
25	co-signer and to support the bill. I'm grateful

3	Minority Leader Jim Oddo, who put this forward and
4	worked tirelessly on it, I wanted to commend him
5	for it. Thank you very much.
6	CHAIRPERSON VACCA: Thank you,
7	Council Member Ignizio. I join in commending
8	council Member Oddo. From the very inception of
9	this proposal, I thought that this was a very
10	important piece of legislation and as Council
11	Member Ignizio indicated, it will shed light on
12	why, what is done, when it's done and where we go
13	from here when it comes to making sure that street
14	surface conditions are kept in good shape in our
15	neighborhoods.
16	I'd like to introduce the members
17	of the Committee who are here: Council Member
18	Jessica Lappin, Council Member Dan Garodnick,
19	Council Member Vincent Ignizio, Council Member
20	Peter Koo, myself, James Vacca, Council Member
21	Debbie Rose, Council Member Ydanis Rodriguez,
22	Council Member Gale Brewer. The Chair recommends
23	a yes vote on this intro and I will ask the clerk
24	to call the roll please.

10	is when they repave the roads-because they did do
11	ten in my district this past summer, and that was

13	and then in addition, there's a lot of noise, and
14	if he could just get rid of all the noise too,
15	that would be great. Thank you.

9	bill. It's a really important bill for our
10	community. Thank you.

12	affirmative, zero in the negative and no
13	abstentions, item is adopted. Members, please
14	sign the Committee Report.

16	adjourn, can you add my name to the bill as well?
17	Okay. I am leaving the vote open for 30 minutes
18	as some members are en route. Okay? Thank you
19	for reminding me. Without further to do, we are
