2 CHAIRPERSON FERRERAS: Good

morning. I'm Council Member Julissa Ferreras,
Chair of the Women's Issues Committee. Before I
start my statement I just want to acknowledge thebecause it's Women's History Month, the members
of the Women's Caucus have all brought in a
distinguished young lady from their district to be
Council Member for the Day, and I want to
acknowledge Sherique Roper [phonetic], from the
Young Women's Leadership Academy, and she's the
representative of our Council Member Annabel
Palma. So, welcome.

CHAIRPERSON FERRERAS: I'd like to thank my colleague, Council Member Dromm, Chair of the Committee on Immigration, for co-sponsoring Resolution 1064-A. The Violence Against Women Act is a historic and crucial piece of legislation that has had tremendous positive impact on our society. It has changed language, legislation and attitudes. It has enhanced services and educated untold numbers of people. It has saved lives.

VAWA has shed light on intimate partner violence, sexual assault, stalking, and the hidden world of

violence. It has enabled thousands of victims to
leave abusive situations, getting housing and
getting help along with a new beginning and a
fresh start. It has provided tools to law
enforcement to assist in combating such crimes.
It has aided in changing our societal notions
about who the victims are and how we can help them
heal. It has shown us that victims can be young,
old, or male and female. We know so much more
now, thanks in large part for VAWA. At our
February 27th hearing on Resolution 1064, we heard
from numerous advocates, criminal justice experts,
including our esteemed DA from Staten Island, Dan
Donovan; a representative from Brooklyn DA Hynes;
along with written testimony from DA Vance. All
agree VAWA needs to be reauthorized. Everyone who
showed up to testify and everyone who submitted
written testimony supported the resolution. We
took their testimony and made some amendments to
the original resolution, which we are voting on
today. VAWA is currently a victim of a logjam of
partisan politics in Washington, DC. Today I ask
you to vote yes on Resolution 1064-A, in order to
lend our unified voice to support the

COUNCIL MEMBER DROMM: Thank you very much, Madam Chair. Since its initial passage in 1994, the Violence Against Women Act, or VAWA, has assisted innumerable survivors of gender-based violence with its support for vital initiatives here in New York City and throughout the country. Despite the continuing need to dedicate resources to this endemic problem, the reauthorization of VAWA has become ensnared in election year politics. Council Resolution 1064 will send a loud and clear message to congress. Our sisters and mothers and daughters deserve to live lives free from violence. And if they ever experience the terror of rape or sexual assault or intimate partner violence, every effort must be made to bring the perpetrators to justice and to promote healing for the survivors. I want to take a moment to recognize the advocates for pushing the

2	reauthorization of VAWA. Several of these groups
3	testified before the Committee on Women's Issues
4	on two particularly vulnerable groups that will
5	benefitlesbian, gay, bisexual and transgender
6	individuals, and immigrants. Finally, I want to
7	thank my colleague, Council Member Julissa
8	Ferreras, Chair of the Committee for her
9	outstanding leadership on this issue. I also
10	wanted to say thanks to Council Staff Annie
11	Meredith, Joan Povolny, Tai Meah, and my Counsel,
12	Sebastian McGuire. I am proud to stand with New
13	York City's women, and hope that you will join me
14	by voting Yes on resolution 1064. And I think
15	it's particularly important that we are passing
16	this in March, Women's History month. Thank you
17	very much, Madam Chair.
18	CHAIRPERSON FERRERAS: Thank you,
19	and if you may call the vote.
