2	CHAIRPERSON RECCHIA: I apologize
3	for being late. Usually we start on time. I have
4	to apologize. I was in a meeting with the
5	Speaker. Some issues came up this morning we had
6	to resolve. Before we move forward with today's
7	hearing, I'd like to recognize all my wonderful
8	colleagues who have joined us today. To my left,
9	we have Joel Rivera, Karen Koslowitz, Jimmy Van
10	Bramer. To my right, we have Fernando Cabrera,
11	Diana Reyna, Julissa Ferreras, Vincent Ignizio,
12	Gale Brewer and Melissa Mark-Viverito. Okay.
13	We've got it.
14	Today's Finance we have six items
15	on our agenda. We have proposed Intro 18-A,
16	otherwise known as the prevailing wage bill
17	sponsored by my colleague, Council Member Melissa
18	Mark-Viverito and four Land Use items. I just
19	want to give a shout out to Melissa. She did a
20	great job with this bill, and I want to thank all
21	your support and your leadership on this. Let's
22	first start with the City Council's annual
23	operating budget. Under the City Charter, the
24	Council has until March 10^{th} to submit to the mayor
25	its own operating budget for next fiscal year.

2	This date was extended to March 29^{th} and this
3	legislation was passed by this Committee in
4	January. This year, the Council budget totals
5	just over \$52 million, which is the same amount of
6	the Council's budget last year, but reflects a
7	1.5% decrease from the year before in 2010.
8	Before I move on to the next item, I want to make
9	sure that it does not go unnoticed charged
10	with monitoring the operation and performance of
11	city agency, analyzing and improving the city's
12	budget, performance and responsibilities in the
13	land use process, and of course, passing laws.
14	The Council has done all of this with a budget
15	that totals less than one tenth of 1% of the
16	city's total budget, which is over \$65 billion.
17	This is a testament to the remarkable leadership
18	of Speaker Quinn.
19	Our next items are land use items.
20	The following four items will receive property tax
21	exemptions through HPD. The Southern Boulevard
22	Apartments, the Quadrant Properties, HDFC, the
23	Mutual Housing Association of New York in
24	Brooklyn, which provides low rental housing in
25	Council Member Vann's district. The other two are

2	in Council Member Arroyo's districts, and then
3	finally, the Israel Senior Housing, which provides
4	low rental housing for the elderly in Council
5	Member Sander's district. All four members
6	support these items.
7	Last, but certainly not least, we
8	will now turn our attention to a historic piece of
9	legislation, the prevailing wage bill, which is
10	sponsored by Council Member Melissa Mark-Viverito.
11	The intent of this bill is require certain
12	developers who receive government funding and
13	certain building owners who lease space to the
14	city to pay their building services employees the
15	prevailing wage. If you remember, we had the
16	first hearing on this bill almost two years ago on
17	May 11 th , 2010 during the executive budget
18	sessions. At the hearing, we had lots of
19	supporters of the bill. We also had lots of
20	opponents. Supporters were excited that we were
21	able to provide prevailing and competitive wages
22	to a sector of employees that provide necessary
23	services to hundreds of properties and projects
24	throughout the city. Opponents of the bill, who
25	were usually excited, actually who were also very

2	excited in a different way, also had a lot to say.
3	They said that small businesses, manufacturing
4	firms and not for profits would have a difficult
5	time paying the prevailing wage and therefore
6	would relocate out of the city or not enter the
7	city at all. They said that requiring people who
8	receive only \$10,000 in government funding was too
9	low of a threshold to trigger the prevailing wage
10	requirement and would go beyond the realm of big
11	developers that the bill sought to target.
12	They said that prevailing wage would make it
13	difficult to build, operate, manage affordable
14	housing projects. Well, guess what? We heard them
15	all, and we listened. After almost two years of
16	working with the administration and the public,
17	Speaker Quinn and myself and with the input from
18	32 among others, we finally have a bill that
19	provides increased wages to building service
20	workers without causing damages to the financial
21	health of New York City. To do this, we did the
22	following: we increased the financial assistance
23	threshold for developers covered under this bill
24	to \$1 million, we excluded small business, we
25	excluded not for profits, we ensured that truly

2	affordable housing projects were protected, we
3	excluded bids, we excluded manufacturers and we
4	excluded health and hospitals corporation
5	projects. I believe this bill has been
6	substantially improved and is one that we should
7	all be proud of. I want to thank , HPD, BDC
8	and the Mayor's Office, who worked extremely hard
9	with myself and my staff to ensure that the
10	provisions of this bill were written in a way that
11	accomplished our shared goals. I want to thank
12	Council staff who worked on this bill around the
13	clock for months. I want to thank my director of
14	finance, Preston Niblack, first deputy director,
15	Jeffrey Rodus [phonetic], and especially counsel
16	to my Committee, Tanisha Edwards. Let's give them
17	a round of applause. Stand up, Tanisha. Stand
18	up. It's well deserved.
19	[applause]
20	CHAIRPERSON RECCHIA: I'm very
21	proud of her. I want to thank Roman Jeskey
22	[phonetic], Emra Aviv [phonetic], Paul Stain
23	[phonetic] and Anthony Barrudo [phonetic], all
24	played a very important role in this process.
25	Okay? Now, let's give a round of applause to all

2	of them. Okay.
3	[applause]
4	CHAIRPERSON RECCHIA: Now above
5	all, I want to thank the leadership, the Speaker,
6	Speaker Quinn, for her great support for
7	supporting this legislation and her leadership.
8	Her leadership is remarkable. This bill has been
9	around for some time, and it's under the
10	leadership of Speaker Quinn that this bill was
11	transformed into the bill before us today. I am
12	honored to have this bill move through my
13	Committee and have to work so closely with Speaker
14	Quinn, with Melissa Mark-Viverito We have
15	worked together to make sure this bill was
16	something that the Council could pass with pride.
17	We know that we have crossed all our T's and
18	dotted all our I's before passing this
19	legislation. Building service workers been
20	viewed as a gateway to the middle class for New
21	York City residents, particularly for immigrants.
22	By providing prevailing wage to building service
23	employees the Council has taken a big step toward
24	protecting the middle class, and this is just the
25	beginning. At this time, I'd like to recognize

3	Mark-Viverito for a statement, but before we do
4	that, I would like to introduce Leroy Comrie,
5	Robert Jackson, Helen Diane Foster, Oliver Koppell
6	and Al Vann. Council Member?
7	COUNCIL MEMBER VIVERITO: Thank
8	you. Good morning. Thank you, Domenic. I think
9	Domenic summed up the bill very nicely, so I don't
10	think I have to repeat the summary of the bill,
11	but I want to mention as a promoter of economic
12	development, the city commits significant
13	resources, including millions of dollars in
14	subsidies and incentives for development projects
15	across the city. Further, as a tenant, the city
16	spends millions of taxpayer dollars each year
17	leasing space for city agencies from private
18	landlords. This bill we're voting on today stems
19	from the Council's concern that many individuals
20	benefit tremendously from profitable city leases
21	or generous economic development financial
22	incentives. These people are very fortunate;
23	however, many of the same people do not ensure
24	that the building service employees that they
25	employee or use receive the prevailing wage. We

2	wanted to fix this. Because of the Council's
3	work, building service workers affected by this
4	legislation will now see a 35% to 45% increase in
5	their hourly wages. The average cleaner
6	[phonetic] will now make \$24 an hour and plus
7	\$8.76 in benefits. For security guards, they will
8	now make on average about \$12.85 an hour plus
9	\$4.56 in benefits. This legislation makes a
10	difference that building service workers and their
11	families will be able to see and feel and will
12	make a tremendous impact on the lives of many New
13	Yorkers who are in search of employment
14	opportunities that will serve as a vehicle to a
15	middle class standard of living. Our economic
16	development policies must be not only benefit
17	developers and business owners, but to create as
18	many good quality, family-sustaining jobs as
19	possible. This legislation moves us further in
20	this direction and I am proud to be the prime
21	sponsor of this bill. Before I turn the mic back
22	to Domenic, I just also want to extend thanks to a
23	lot of the people that Domenic mentioned, the
24	Chair mentioned. I want to thank everyone who
25	worked diligently on this bill, Preston Niblack,

2	Tanisha Edwards, and Anthony from the
3	finance division as well as my staff. I also want
4	to thank the administration for working with us on
5	the bill and for offering advice I used to
6	improve the bill. It was a collaborative effort
7	by all of us indicated. It took a long time to
8	get here, but I'm very happy that we've arrived at
9	this point, and many, many individuals will
10	benefit from this, and we're a better city because
11	of it. And of course, I want to thank Speaker
12	Quinn in particular, who provided great support
13	for the passage of this bill and to get this to
14	the point where we are. I want to thank obviously
15	the Chair, Domenic Recchia, who sits here and who
16	I'm proud to call a friend. Domenic and I share a
17	lot of the same beliefs and believing that
18	building service workers deserve a competitive pay
19	is one of them you and your staff, Domenic,
20	I've to work on this. I really thank you and
21	for moving this forward in the Finance Committee
22	and for voting on it today. I look forward to the
23	passage of this bill. Thank you.
24	CHAIRPERSON RECCHIA: Okay. Thank
25	you, Melissa. We're joined by Council Member

7	on Finance. Council Member Recchia?
8	CHAIRPERSON RECCHIA: I encourage
9	all my colleagues to vote aye on all. Aye on all.

11	COUNCIL MEMBER RIVERA: I vote aye
12	on all.

17	on all and certainly thank Melissa Mark-Viverito
18	and and Mike was on New York 1 last night,
19	and what he said was, even for those who think
20	Melissa Mark-Viverito mentioned in terms of a
21	hourly, think again because in order to raise a
22	family of four in the city of New York, as Mike -
23	- stated at \$2,000 a month rent, that's half of
24	your salary right there. That's not even enough,
25	so the fact of the matter is that this particular

2	bill when you add it all up is actually not a lot
3	per family, but it is certainly something to
4	strive for, and God knows, those families need the
5	funding and we need their dollars to be
6	circulated in the neighborhood, which is what they
7	will be because those are the families who are
8	investing. I vote aye. Thank you.

10	COUNCIL MEMBER COMRIE: Aye on all.
11	Aye on all.

18	may I be excused to explain my vote?
19	CHAIRPERSON RECCHIA: Yes, you may.
20	COUNCIL MEMBER JACKSON: Thank you.
21	First, let me thank all of the parties that were
22	involved in putting this piece of legislation
23	together and especially getting to where we are
24	today, and obviously, Chair Recchia, you
25	acknowledged the staff involved and all the

2	others for reaching a consensus on a bill in which
3	if when you talk about without benefits, \$10 an
4	hour, \$10 an hour equals times 40 hours a week,
5	which is the average workweek, \$400 a week. \$400
6	a week. Think about that. I want you to think
7	about if you can live in \$400 a week. Then, take
8	out your calculator and put times 52. That's
9	\$20,800 a year. Mind you, that's gross, not
10	including the tax they take out, not including
11	anything else. That's gross. You think about
12	that. And if you say no, if anyone says no to
13	this piece of legislation, then think about what
14	those now, and then I want you to live off of
15	that for a year and come back here and tell us no.
16	So with that, Mr. Chair, I want to thank all of
17	the parties involved. I understand our Mayor Mike
18	Bloomberg said he would veto this, and I
19	understand from our Speaker that we have enough
20	votes to override it. Clearly, this is a good
21	piece of legislation knowing that we're talking
22	about organizations that receive city subsidies of
23	a million dollars or more and it excludes many
24	small business, so I thank all of those involved,
25	and I emphatically vote yes.

24	and I've said before and they know this that I was
25	raised by my stepfather who was a janitor and he

3	today, he would be a member of local authority
4	, and it is a great day for workers and for
5	justice in the workplace, and every little bit
6	helps when you're struggling to pay the rent. I
7	just want to congratulate the Speaker and everyone
8	for making this day happen for who worked
9	every single day, and to veto a bill like this, I
10	think is just incredibly wrong to deny people what
11	is rightfully theirs, which is dignity and every
12	single worker should have that. Thank you.

25	adopted by a vote of 14 in the affirmative, two in
