3	afternoon. My name is Maria del Carmen Arroyo. I
4	chair the Committee on Health in the Council.
5	Today we will be voting on pre-considered
6	Introduction sponsored by Council Member Jessica
7	Lappin, which would require the Department of
8	Health to post on their website links to groups
9	performing trap, neuter, return TNR [phonetic]
10	activities and services and would repeal the
11	requirement that the Department promulgate rules
12	related to TNR activities in the city. TNR is a
13	strategy to humanely and effectively manage feral
14	cat populations and colonies. The Committee
15	previously heard testimony on this legislation on
16	August 17 th , 2012. Multiple animal advocacy
17	organizations attended and testified in favor of
18	this amendment and we received testimony for the
19	record from the Department of Health in favor of
20	the legislation. In September of 2011, the
21	Council passed Local Law 59, which included a
22	provision requiring the Department of Health to
23	promulgate rules to register individuals and
24	groups performing TNR activities; however, based
25	on discussions with animal advocates involved in

2	TNR services it became clear that the animal
3	advocacy community generally supports the way TNR
4	activities are currently performed in the city and
5	that there was no need for the Department to
6	create a registration system, but rather the
7	Department should simply post links to TNR groups
8	on its website. Thus, this pre-considered bill
9	would ensure that TNR will continue to be done by
10	private entities with no involvement from the
11	Department of Health. I know that there is
12	another vote going on right now and Council
13	Members will be going and coming and I will now
14	ask the clerk to call the roll and ask that it be
15	held open until we can get the other members of
16	the Health Committee an opportunity to vote. Call
17	the roll.
18	COMMITTEE CLERK: Kevin Pin,
19	Committee Clerk. Roll call in the Committee on
20	Health. Council Member Arroyo?
21	CHAIRPERSON ARROYO: I recommend an
22	aye vote. Aye.

25	that our Chair said with no involvement from the
