of the City Planning Commission.

The City Planning Commission has 13 members, 7 appointed by the mayor, 1 by the public advocate and 1 by each of the borough presidents. The Planning Commission is responsible for the long range planning to ensure orderly growth and development, assist in developing the ten year capital plan, prepares and modifies the zoning resolution, among a number of other critical functions. Commission members serve five years terms. There is no limitation on the number of terms that a CPC member may serve. CPC members are prohibited from holding any other city office while they serve on the Planning Commission. chair receives an annual salary of \$205,180. member who is designated as vice chair receives an annual salary of \$62,271 and the other members receive an annual salary of \$54,150.
