2	CHAIRPERSON DILAN: Good morning
3	everyone. My name is Erik Martin Dilan. I'm the
4	chairperson of the City Council's Committee on
5	Housing and Buildings. And today the Committee
6	will hear a piece of legislation for the purposes
7	of a vote on proposed Intro 404-A in relation to
8	fines for illegal conversions of dwelling units
9	from permanent residences. Proposed Intro 404-A
10	takes into account changes made to New York State
11	law in the year 2010, which outlawed the use of
12	permanent residential units as hotels by creating
13	a specific violation in New York City's
14	administrative code for the illegal conversions of
15	permanent residential units. It would also
16	require that a repeat violation for the illegal
17	conversion of a permanent residence or a violation
18	to more than one unit in a building be classified
19	as immediately hazardous and subject to a penalty
20	in the range of \$1000 to \$25,000. This
21	legislation we deem is necessary for a number of
22	reasons. First is that the illegal conversion of
23	permanent residential units exposes visitors to
24	our city and building residents to very serious
25	safety risks. Our building and fire codes require

2	certain safety standards for legally operating
3	short term stay facilities and safeguards that
4	most illegal hotels do not offer. Second, as this
5	committee heard in March of this year when we
6	voted to extend rent regulations that New York
7	City continues to suffer a housing crisis with an
8	apartment vacancy rate of just 3.1%. The illegal
9	use of permanent apartments has the potential to
10	worsen this already severe crisis by narrowing the
11	market for available housing and therefore,
12	driving up rental costs. Finally, illegal hotels
13	can worsen the quality of life for permanent
14	residential occupants that reside in building uses
15	where existing short term stay visitor traffic
16	exists where they have to co-locate and live
17	together, creating a greater likelihood of
18	nuisance issues, safety concerns, and public
19	health risks. Now we understand that not
20	everything in the state law and the law before us
21	today is perfect and there are some legitimate
22	people out there that may be affected by this and
23	we may continue to listen to these, but short of
24	that, we recognize that the whole of this bill is
25	better than the few minor deficiencies that it has

2	and recognize in these economic realities I would
3	state that the Council is open to working on these
4	issues to identify how they can be formalized and
5	allowed to be legally operated, but until such
6	time, I believe that we should move forward on
7	this bill in its current state, and ask my
8	colleagues to vote in favor of this legislation,
9	and would like to ask the original sponsor of the
10	bill, Council Member Gale Brewer if she wishes to
11	make a comment.
12	COUNCIL MEMBER BREWER: Well, I
13	certainly want to thank Chair Dilan, Speaker Quinn
14	and the Mayor's Office and certainly all of the
15	advocates as well as the union representing the
16	workers in the hotels and certainly the Hotel
17	Trade Association. All of these individuals have
18	spent a great deal of time thinking about this
19	issue and trying to come up with some solutions,
20	and I second everything that the Chairman
21	indicated. I want to just state that as Ann
22	Cunningham knows who is sitting here today, the
23	individuals living in single room occupancies,
24	residential hotels and places where there has been
25	an illegal hotel use it's very challenging when

you're getting up for work in the morning to have 2 somebody living next to you often live a thin wall 3 4 situation, who has been out partying all night. 5 That doesn't always happen, but that is often the The room next door, the unit next 6 situation. 7 door, the apartment next door, I think should be 8 for somebody who is going to be your neighbor on a 9 long term basis. That's number one. Number two, 10 some of these conversions that have gone illegally 11 to hotels are often a fire danger. We have met 12 with the fire department on many occasions. As 13 anyone who has stayed in a regular hotel knows, 14 there needs a second point of eqress, there are 15 many different kinds of sprinkler systems, and the 16 list goes on. The fire department has to know for 17 instance where are the walls, where are the rooms. God forbid, there is a fire, they have to know and 18 19 that is the kind of information that is normally 20 in a hotel filed with the Department of Buildings, 21 so there are unforeseen problems that exist when 22 an illegal hotel takes over, and then finally, I 23 want to recognize the fact that we are a city of 24 tourists-thank goodness. It's a big economic boom 25 for the city of New York, but we would like to

2	have more quality, legal, low cost tourist
3	accommodations. I know for instance at the
4	American Youth Hostel on 103 rd Street on the West
5	Side is such a wonderful place. 654 bunks every
6	single night are filled and we need more, but we
7	need them like that-legal and safe for those who
8	are using them. Of course as the Chair indicated,
9	the real reason for all of this is to provide more
10	permanent, affordable housing for the many New
11	Yorkers who need it, and I really thank the
12	Chairman for this particular piece of legislation
13	and for holding the hearing today and the Speaker.
14	Thank you very much.

16	Council Member Brewer. Alright. We have to wait

13	Chairman, I think it's pretty well established at
14	this point that there are few folks in city
15	government or government for that matter for whom
16	I have as much respect as I do for Council Member
17	Brewer. I think she does this job the way it's
18	supposed to be done, and she is engaged in her
19	community and knows her community better than
20	anyone, but we're going to disagree on this one.
21	I think the short stay rental industry as best as
22	I understand it needs to get the relief it seeks
23	in Albany in terms of an exemption from the
24	existing law and new laws to regulate the
25	industry, but I'm just struck by the fact that we

2	all talk about jobs and small business. You have
3	Greg David [phonetic] from Queens essentially
4	making the argument that tourism has replaced
5	manufacturing in its role in our economy. This is
6	an industry that's my understanding %150-150
7	million and I think it's important that we
8	recognize it and cultivate it and help it, and I
9	don't believe-I believe my colleagues share that
10	view. I think it's from my point of view, I think
11	it's a statement if you will to vote no, not so
12	much against this bill per se, as much as it's a
13	symbol and a message to the industry that we
14	understand they need help and that we as an
15	institution here and the Council need to go up to
16	Albany and advocate on their behalf so that they
17	get the relief they need so that we grow that
18	industry and we provide not only my understanding,
19	not only spots for tourists, but for other short
20	stay needs whether they are filming in New York
21	City, et cetera, so with much respect to Council
22	Member Brewer and with a tip of the hat to the
23	industry that we as a Council will try to go to
24	Albany to help you, I'm going to respectfully vote
25	no.
