21	Community Board district 16, and that is in
22	Council district 41, that's the Council district
23	represented by Council Member Darlene Mealy.

CHRISTOPHER GONZALEZ: Good
morning, good morning, committee members, Chair
Levin. I am Christopher Gonzalez, Assistant
Commissioner of Government Affairs at HPD, I am
joined by Sal D'Avola, Executive Director of
Neighborhood Homes and Restored Homes.

Land Use item 719 consists of an amended project and proposed disposition of a vacant City-owned lot located at Block 1475, Lots 39 and 78. Under the Asset Control Area Program, the Council approved a tax exemption on September 21st, 2011, for property located at 1413 Pitkin Avenue. Located adjacent to 1413 Pitkin Avenue is a City-owned lot, 37, also known as 1416 Eastern Parkway Extension.

The sponsor proposes to utilize this 756 square foot lot as a backyard for the 1413 Pitkin Avenue building. The home has been conveyed to the new owner, however, the lot line is so close to the home that it does not allow escape in case of emergency. Combining the two lots into one project area will solve the egress issue, therefore, HPD is seeking to amend the

2	prior approval in order for both properties to be
3	combined to form one project area and facilitate
4	one tax exemption authorization for both
5	properties.
6	Council Member Mealy's office has
7	been briefed on this project.
8	CHAIRPERSON LEVIN: And Council
9	Member Mealy is in support of the proposal?
10	CHRISTOPHER GONZALEZ: Yes.
11	CHAIRPERSON LEVIN: Great, okay.
12	Very good. Okay. I have no further questions on
13	this item, do any of my colleagues have any
14	questions on this item? Seeing none, I thank you
15	both very much for coming out this morning, and we
16	will close the hearing on Land Use number 719.
17	Thank you.
18	CHRISTOPHER GONZALEZ: Thank you.
