4	Michal Nelson. I chair the Committee on Civil
5	Service and Labor. Today we're voting to file the
6	Mayor's veto of Intro number 97-A, Mayoral message
7	1159-2013 of the Earned Sick Time Act, commonly
8	referred to as the Sick Paid Time Bill. We've
9	held four hearings on this bill and made major
10	amendments to it. The benefits to public health
11	in this city have been discussed at length and it
12	was overwhelmingly passed by the full Council in
13	May. Today, I recommend to the Committee that we
