Okay, okay. Good morning. I'm Council Member Michal Nelson. I chair the Committee on Civil Service and Labor. Today we're voting to file the Mayor's veto of Intro number 97-A, Mayoral message 1159-2013 of the Earned Sick Time Act, commonly referred to as the Sick Paid Time Bill. We've held four hearings on this bill and made major amendments to it. The benefits to public health in this city have been discussed at length and it was overwhelmingly passed by the full Council in May. Today, I recommend to the Committee that we file the Mayor's veto and repass it. We've been joined by members of the Committee, Council Members Mark-Viverito and Recchia. And I would also like to thank the Committee staff, Matt Carlin [phonetic] our Counsel and Faith Corbett [phonetic] our Policy Analyst. Now, we will vote. Will the Clerk please call the roll?

COUNCIL MEMBER GENNARO: Yes.

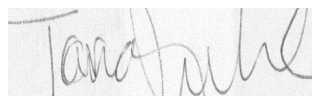
CHAIRPERSON NELSON: The vote now stands at four in the affirmative. [off mic]
