9	Legislation Committee. Today we will be considering
10	two Mayor's Messages.
11	First I would like to introduce the
12	members of the Committee that are present at this
13	time Council Member Rafael Espinal, Council Member
14	Inez Dickens and Council Member Ben Kallos.
15	The Committee will hear and vote on a
16	Preconsidered Mayor's Message requesting passage of
17	Senate Bill 6624, which extends the city's ability to
18	invest in certain short-term assets to June 30th,
19	2017. The City often has funds that it does not
20	immediately need; it invests these funds in short-
21	term assets such as Treasury bills and high-quality
22	commercial paper so as to earn some interest. The
23	authority to invest in certain short-term assets
24	including commercial paper expires on June 30th; the
25	bill extends this authority for three years. Without

 this bill the City would be restricted to investing
 in T-bills, which earn very little. The Comptroller
 estimates that failure to extend this authority would
 cost the City about \$10 million in Fiscal 2015.

Additionally, the Committee will be 6 7 considering a Preconsidered Mayor's Message which requests the passage of Senate Bill 7386 and Assembly 8 Bill 9462. This legislation would extend the City's 9 10 authority to impose five city taxes at their current rates for three years. This includes the City's 11 12 personal income tax, general corporation tax and 13 cigarette tax.
