2	CHAIRPERSON RODRIGUEZ: Good morning and
3	welcome to today's hearing of the City Council
4	Transportation Committee. My name is Ydanis
5	Rodriguez and I am the chair of this committee.
6	First, let me recognize my colleagues who are here
7	today: Council Member Garodnick, Chin, Van Bramer,
8	Weprin and Constantinides.
9	Today we will vote on a very important
10	piece of legislation: Proposed Intro 371, a intro by
11	majority leader Van Bramer and I, which will impose
12	civil penalty on hit-and-run drivers on top of any
13	other penalties imposed by state law. It is very
14	obvious that not only the law, but basically human
15	decency requires all of us to stop and remain at the
16	scene of any incident on the road; most importantly,
17	to ensure that proper medical care reach anyone who
18	needs it as quickly as possible and yet, it still
19	happens all the time. Cowardly drivers flee the
20	scene with no regard to human life or the basic
21	responsibilities that come with the privilege of
22	driving on our streets. The laws on the book don't
23	seem to be enough and that's why we are acting today.
24	Our hearing on these bills we heard, that we have

heard all too often before, drivers who hit and run

2 add so much to the anguish of victims and their loved In order to make this law as strong a 3 ones. deterrent as possible, since that hearing we have 4 doubled the fines prescribed in the bill, which now 5 go up to \$10,000 for the incidents that result in 6 7 critical injury and/or death. Although we know that no amount of money will ever compensate the victim's 8 family, we hope that this legislation will bring some 9 comfort to the families. It is also important to 10 point out that because this law would impose civil 11 12 penalties, it should make it easier for the city to 13 pursue these cases that inherently is to meet the 14 highest standards of proof needed to put state's 15 criminal charges.

16 As I mentioned at the first hearing on 17 this bill, Intro 371 is also an example of the 18 Council doing what it can to legislate on our own to advance street safety without relying on the action 19 20 in Albany. At the same time, we need our colleagues at the state level to act on many important proposals 21 2.2 to make all of us safer including and in the perverse 23 incentive that currently extends to drunk drivers to hit-and-run in order to avoid the penalty for DUI, 24 which can be higher than leaving the scene. 25

2	I am very proud to have co-lead [sic]
3	Intro 371 with our majority leader, Jimmy Van Bramer.
4	We are committed to issues of street safety, which is
5	why this piece of legislation is so important to us.
6	We hope this legislation will really make drivers
7	think twice about their basic responsibility on the
8	road.
9	I now invite our majority leader, Jimmy
10	Van Bramer, to deliver an opening statement.
11	COUNCIL MEMBER VAN BRAMER: Thank you
12	very much, Mr. Chair, for your co-sponsorship of this
13	bill for the strengthening of this very important law
14	and for your indefatigable leadership with respect to
15	achieving Vision Zero, so I want to thank you for
16	everything you've done, and like for yourself and for
17	so many members, this is personal. Almost a year
18	ago, Luis Bravo, a 19-year old, was struck in
19	Woodside Queens and instead of stopping to help him
20	and to see if maybe there was something that could be
21	done for him, the driver fled the scene, leaving Luis
22	Bravo to literally die in the street. His mother,
23	Martha, is following this very important piece of
24	legislation and I know, because we have heard from
25	her, that our actions today and tomorrow are bringing

2	her some comfort and it is so, so important that we
3	do all that we can to make sure that those who flee
4	the scene of a collision and leave people to die
5	would be punished as much as they possibly could, and
6	this very important bill, Intro 371, is filling a gap
7	that currently exists that most people don't know
8	exists and while it cannot bring Luis Bravo or Kuma
9	Ragunath or Karen Feras (phonetic] back, three
10	individuals who were killed in my district in the
11	last 18 months alone, by hit-and-run drivers. It can
12	and I believe will serve as a deterrent to those who
13	would do the same thing to others. We know this
14	happens all the time, far too often and I believe
15	this bill will save lives.
16	So I want to thank again, our chair for
17	co-sponsoring this legislation with me. I'm proud to
18	have introduced this. I want to thank all of our
19	colleagues, the 20 colleagues who have signed onto
20	this legislation and all of the staff who were
21	involved in making this possible and I'm proud of
22	this and tomorrow will be an even more proud day when
23	Luis's mother will join us at the City Council for

24 this very important bill. Thank you so much.

CHAIRPERSON RODRIGUEZ: Thank you, majority leader. I would like to recognize also my colleague, Council Member Levine [sic], Miller and Greenfield and if any of my colleague has anything to say before we take a vote. No?

7 Before we do the roll call, I would like to dedicate this vote to the victims of hit-and-run 8 and to the courage of their family members. Your 9 death has not been in vain and we will work until 10 these laws are performed and justice is served. As 11 12 my colleague also has had so many cases in his 13 district, I also would like to recognize one other 14 victim that was personally connected with me, Josbel 15 Rivera, who I knew his family before he was born and 16 Josbel Rivera was a recent college graduate student, who crossing Mosholu Parkway, he was hit, the driver 17 18 left the scene and a few hour after he left the scene you can see in a video in the Facts Finder that a few 19 20 hours after he put his car on fire to get rid of the evidence and still, it took two years for his mother 21 2.2 to be able to see justice and at this moment the 23 driver is only doing like two years in jail, so as we have reason Josbel, we have so many other big thing 24 and those families they are suffering every day. 25
