3	SPEAKER MARK-VIVERITO: Okay, we're
4	waiting for a mic, but I think we're gonna get
5	started. I wanna thank all my colleagues that are
6	here; this is a little bit out of the norm that we're
7	starting our ceremonial so early, but I thank
8	everyone for accommodating it; we needed a little bit
9	more time at 1:00, since we have special guests
10	coming and a special ceremony happening, so I wanna
11	thank everyone for at least allowing us to move this
12	up a little bit; we have four ceremonials that we
13	wanted to get given to those who are receiving them
14	before we start the actual Stated Meeting.
15	And the first one, which I'll be doing
16	with all of my colleagues, but in particular the
17	Women's Caucus… [cheers, applause] for Cervical
18	Health Awareness Month, it's a proclamation that we
19	are giving to a survivor who has now become an
20	advocate. But I'll say that also what we're gonna be
21	doing in this Stated today is passing two
22	resolutions; this is an issue obviously that I've
23	been very vocal about most recently, but one
24	resolution declares January Cervical Health Awareness
25	Month; we know that we want women to get tested,

2	women to go to their gynecological exams very often
3	and frequently, as they should. So one reso, we'll
4	do that later too we're voting on and the second one
5	is to basically eliminate the need for parental
6	consent for those who wanna get the vaccine for HPV
7	and that is to help obviously stave off and prevent
8	cancer in the future.
9	So today though we're gonna be honoring
10	an advocate who is a survivor who has become an
11	advocate; her name is Patti Murillo-Casa… [cheers,
12	applause] who has brought more awareness of this
13	terrible disease and its connection to HPV. So what
14	we'll do, hopefully we'll get the mic before she
15	speaks. We wanna thank all of my colleagues that are
16	here; we want the Clerk to read the resolution so we
17	can hear all about our wonderful, wonderful advocate
18	and survivor, Patti and then we'll hear from her
19	directly. So with that I'll ask the Clerk to read
20	the proclamation.
21	CITY CLERK: Council, City of New York
22	Proclamation.
23	Whereas in observance of Cervical Health
24	Awareness Month, the Council of the City of New York
25	is proud to honor Patti Murillo-Casa for her

2	courageous commitment and meaningful advocacy work.
3	And whereas, Ms. Murillo-Casa is truly one of New
4	York City's finest. Before her retirement she worked
5	for 20 years protecting and serving our community as
6	an NYPD Police Officer. Throughout her career she,
7	like so many police officers, regularly put the
8	safety of strangers above her own day in and day out.
9	In 2008, shortly after she retired, she was faced
10	with an unprecedented threat, a diagnosis with Stage
11	2B cervical cancer. And whereas, Ms. Murillo-Casa
12	endured eight treatments of chemotherapy, 35
13	treatments of radiation and two treatments of
14	internal radiation (brachytherapy), but with the
15	profound support of family and friends she
16	persevered, yet two years after her difficult battle
17	with cancer problems continued to grow; she became
18	obese and developed Type 2 diabetes, high cholesterol
19	and high blood pressure. With great doctors and even
20	greater determination, she lost 113 pounds in 14
21	months; [cheers, applause, comments] she recognized
22	how health is wealth, especially having been on the
23	other side and resolved not only to keep her weight
24	down but to educate others about cervical cancer, as
25	well as obesity. And whereas, today Ms. Murillo-

2	Casa's cancer has been in remission for five years
3	[applause, cheers] and she is healthier and stronger
4	than ever before; demonstrated the great character of
5	the best NYPD officers, she refused to be paralyzed
6	by her horrible episode and was strengthened by it;
7	she is now president of the NYC Chapter of Tamika and
8	Friends, Inc. survivor, a not-for-profit organization
9	dedicated to raising awareness about cervical cancer
10	and its link to the human papillomavirus (HPV). In
11	this role she shares her story of surviving and
12	thriving and advocates for empowerment through
13	knowledge, prevention and early detection. And
14	whereas, Ms. Murillo-Casa is also an active member of
15	the Woman to Woman program at New York Presbyterian
16	Hospital, which supports and mentors women newly
17	diagnosed with gynecological cancers and offers
18	ongoing emotional support while undergoing
19	treatments. She can be frequently seen giving
20	presentations and attending health fares across the
21	five boroughs to increase awareness on preventative
22	measures that may prevent a cervical cancer
23	diagnosis. In all of her appearances she reminds
24	everyone that no one should lose their fertility or
25	die from cervical cancer and that no one should feel

2	alone in their fight. Now therefore be it known,
3	that the Council of the City of New York gratefully
4	honors Patti Murillo-Casa for her outstanding
5	advocacy work in the fight against cervical cancer

8	Health; Laurie A. Cumbo, Chair, Committee on Women's
9	Issues; Elizabeth Crowley, Co-Chair, Women's Caucus;

19	today, so thank you for that. And we don't have the
20	mic yet and that's fine; we'll hear from Patti, but I

23	like, Darlene and also the Chair of our Women's
24	Committee, if it could be brief and then we can
25	introduce Patti and hear from her.

9	cheers] and this nation. Thank you.

21	HPV are preventable; there are new diagnoses and
22	there are new things that out there to make sure that
23	we prevent this; there's a new vaccine that is going
24	to be released this year that's going to prevent nine
25	strands of cancer, so this is historical; this is

2	going to prevent so many forms of cancer like
3	cervical cancer, but it's so important that we take
4	away all of the stigmas associated with getting
5	tested, with learning more about HPV, learning more
6	about these different forms of cancer and knowing
7	that they are preventable if we just educate
8	ourselves and take away the stigmas. So I appreciate
9	you for your work in making sure that we break down
10	those stigmas and break down those barriers and make
11	sure that we educate ourselves on the importance of
12	these vaccinations.

14	you, Laurie. And now we will finally got the mic,
15	great, just in time and we'll hear from Patti. Here
16	you go.
17	PATTI MURILLO-CASA: Thank you. I just
18	wanna thank all of you, the Women Caucus and our
19	Council Speaker for this great honor, but this honor
20	I share with 12,000 women that are diagnosed with
21	cervical cancer every year and the 4,000 women that
22	die every year. I also share it with the advocates
23	like myself that are there [background comment]
24	always fighting to bring the education to other women
25	and to let them know that our journeys don't have to

2	be theirs, because this is one of the cancers that
3	could be preventable because we have the tools and we
4	have the tools to prevent it; we just have to know
5	about them. And I, like my other advocates, share
6	this vision that one day in the future there will be
7	no cervical cancer.

9	PATTI MURILLO-CASA: Thank you. And as a
10	retired police officer, I'm honored to stand here
11	with my brothers and sisters supporting Detective
12	Ramos and Detective Liu on their sacri… I get
13	emotional we won't forget the sacrifice that they
14	gave for our city and I'm here standing right next to
15	my brothers and sisters. Rest in peace brothers.
16	Thank you.

18	SPEAKER MARK-VIVERITO: Thank you, Patti;
19	that means a lot. And again, it's just incredible
20	how the synergy happens, 'cause I really did not
21	know, in recognizing you today in terms of the
22	ceremony we were doing today that you had a

Sisters as a force in this city and this nation. So
many people come from irregular families; I grew up
with a single parent and there are a lot of single-
parent households out there and in fact one of my
staff members also grew up with a single parent and
for him, Big Brothers and Big Sisters really filled a
big void in his life; in fact, looking back in
hindsight I wish I had had a chance to take advantage
of it as well and I hope as many of our City's
children can have the opportunity to have the
mentorship that is offered by Big Brothers and Big

2	Sisters. This City Council is pleased to honor Big
3	Brothers Big Sisters this January for National
4	Mentoring Month, a special time to recognize the
5	tremendous influence that adults have in the lives of
6	children, whether members of our family or members of
7	the community at large. Volunteering their time and
8	offering love, guidance and support, they serve as
9	positive role models, helping to instill valuable
10	life skills and empowering young people to pursue
11	their highest aspirations and realizing their full
12	potential.
13	For 110 years Big Brothers Big Sisters,
14	the nation's largest donor and volunteer-supported
15	mentoring network, has partnered with parents,
16	guardians, schools, corporations and others in the
17	community to carefully pair children, known as
18	"littles" with screened volunteer mentors, known as
19	"bigs" and monitors to support those 1:1 mentoring
20	matches through their course; many littles are from
21	single- or low-income households or families where a
22	parent is incarcerated or serving in the military,
23	but thoughtfully chosen 1:1 mentors change their
24	lives for the better forever.

6	Whereas in celebration of National
7	Mentoring Month, the Council of the City of New York

9	extraordinary role in shaping the lives of countless
10	young people throughout New York City and across the
11	nation. And whereas, National Mentoring Month,
12	January, provides a special time to recognize the
13	tremendous influence that adults have in the lives of
14	children, whether they are members of our family or
15	members of the community at large. And whereas, the
16	unique paradigm that Big Brothers Big Sisters offers
17	regularly leads to a wide range of positive results,
18	from educational success and the avoidance of risky
19	behaviors to higher aspirations, greater confidence
20	and better relationships. And whereas, in 2012 the
21	first Big Brother Big Sister's Youth Outcome Summary
22	substantiated that its mentoring program has proven
23	positive academic, socio, emotional and behavioral
24	outcomes for youth. The research revealed that after
25	18 months of spending time with their bigs, the

3	children not in our program, were also 33 percent
4	less likely to hit someone, 27 percent less likely to
5	begin using alcohol, 40 percent less likely to using
6	illegal drugs; 52 percent less likely to skip school.
7	And whereas, with about 350 agencies across the
8	United States, Big Brothers Big Sisters now annually
9	serves nearly 630,000 children, volunteers and
10	families. Big Brothers Big Sisters marks National
11	Mentoring Month with the launch of a nationwide
12	campaign to locate and reunite with former bigs,
13	littles, donors and staff, board and family members.
14	By bringing alumni together and showing them how
15	appreciated they are, we reaffirm our commitment to
16	supporting others who are currently invested in
17	efforts to help kids succeed in school and life. And
18	whereas, Big Brothers Big Sisters has changes lives
19	of struggle to lives of success by establishing a
20	strong connection between children and responsible
21	adults, they have changed the course of communities

18	On behalf of the agency, I'm Hector
19	Batista; I'm the Executive Director and CEO of the
20	organization. This month marks National Mentoring
21	Month, but it's also particularly important because
22	this year we celebrate our 110 years of service. And
23	let me just tell you a little bit about the
24	organization. We've been around for 110 years, when
25	Ernest Coulter called to action to get one volunteer

2	to help this young man who was about to be in trouble
3	with the law; that started the movement in 1904;
4	today the need is the same. In New York City there's
5	about 250,000 children that live below the poverty
6	rate and come from single-parent households and
7	that's the population we're trying to service. We
8	service about 4,000 a year and we service them
9	throughout the country also. For us, having a big
10	brother or big sister in their lives makes such a big
11	difference. And let me give you some stats. After
12	being in our program, 90 percent of our kids get
13	promoted to the next grade, 96 percent of them are
14	graduating from high school and 86 percent of them
15	are going on to college. Those are numbers that
16	speak for themselves and we're an evidence-based
17	organization; we recently completed a two-year study
18	of our program that validated those stats and the
19	most important thing of our program is that young
20	people, we lessen the risky behaviors and that's why
21	the program is so effective. So today I particularly
22	wanna thank the City Council not only for their
23	financial support, but also for recognizing the
24	organization because it gives us the opportunity to
25	call out; I was before trying to recruit a couple

2	police officers, because we need men volunteers as
3	much as we need women volunteers, so it is important;
4	I never stop recruiting because our kids could use a
5	mentor; these are the kind of things we take for
6	granted, some of us who have had those mentors in our
7	life, so I wanna thank the City Council for

9	organization. Thank you very much.

9	the greatest city in the world; crime statistics show
10	that the rate of major crimes committed is being
11	drastically reduced in New York City year after year.
12	In 2014, crime rates reached record lows; most

14	grateful for the work of the entire NYPD,
15	particularly the 108th Precinct in Queens to which

This has a modest 2.2 cost; we think it's easily achievable, with benefits 23 for health and safety and well-being of young people 24 and all New Yorkers. Thank you.

24	prevention estimates that about 10,000 women in the
25	United States are diagnosed with cervical caner

3	they meet and year after year they raise the rent on
4	rent stabilized tenants; this must not continue. The
5	Rent Guidelines Board uses unreliable data to
6	determine landlords' expenses, the price index of

8	expenses by as much as one-third, more than 2.5
9	million New Yorkers live in approximately one million
10	rent stabilized apartments in New York City; that's
11	46 percent of all rental units. It is crucial that
12	the City protect these tenants and ensure that any
13	adjustments or increases are fair and based upon
14	accurate data that does not overinflate the property
15	owner's true costs of operating and maintaining the
16	units and considers the income received by property
17	owners. There are RGBs in Westchester and Nassau
18	Counties; they do not use the price index and they
19	have frozen rents several times while the City RGB
20	has never done so; instead they require landlords to
21	file INE [sic] numbers every year with the State
22	Division of Housing Community Renewal, the City uses
23	15-month-old numbers, but former Finance
24	Commissioner, Martha Starr testified to the RGB that
25	if instructed by City Hall they could provide numbers

3	and empower the RGB with correct and current
4	information about the status of rent regulated

9	announce reforms in the sake of fairness for tenants.

10	people are upset; shame on them, shame on them for
11	hating Jews, shame on them for hating people; shame
12	on them for disrespecting the most diverse
13	democratically elected body in the United States of
14	America and that's why we go to Israel, we go to
15	Israel to make a message that is clear that we will
16	not be cowered by this fear and by this hatred that
17	we have, where these are people who would celebrate
18	the death of Jews rather than mourn the death of
19	innocents. I am embarrassed of what happened here
20	today, but I am please that we finally see what this
21	is all about, good old fashioned anti-Semitism.

20	about these programs for SCRIE and DRIE, more seniors
21	will know that they can apply for a rent freeze and
22	that could mean the difference for a senior between
23	being able to age in place or being priced out of a
24	home. The second is Res 0540, which I'm introducing
25	with Council Member Dromm, Council Member Mendez and

3	address a policy which allows a charter school to
4	change school districts within a borough without a
5	new public hearing being held. This is because
6	apparently, even if you are switching from my
7	district to Council Member Rodriguez' district it is

9	calls for SUNY to hold new hearings whenever they
10	change districts to that they local impacted
11	community has real opportunities to comment. So I
12	urge my colleagues to join me in signing on to these
13	legislations. Thank you.

21	terminal off the coast of New York. LNG is a natural
22	gas cooled to extremely low temperatures to reduce
23	its volume for transport. At this altered state,
24	liquefied natural gas is highly volatile, consists
25	almost entirely of methane and it's to be expected

2	with hydrocarbons to have a great carbon footprint.
3	Liberty Natural Gas purports Port Ambrose, which will
4	be used as an import facility of LNG for domestic
5	use. Current market indicators reflect that it is
6	far more profitable for natural gas producers to
7	export their product overseas where natural gas can
8	command a higher price. Domestically emergency
9	production has done so well that the likelihood of an
10	update in market price is not likely to occur anytime
11	soon. As we face a threat of rising temperatures and
12	the volatility of climate change, government must do
13	what is necessary to reverse the damage incurred as a
14	result of human activity. LNG will not further any
15	resilient, efficient and environmental goals; as a
16	city and as a state I implore my colleagues to
17	support this resolution and to call on Governor Cuomo
18	to help maintain the planet and its remaining
19	resources for present and subsequent generations.
20	Secondly, I have an Int 0633, which will
21	require the City to require building managers to file
22	energy audit reports every five years instead of 10
23	years. As our City continues to commit to reducing
24	its consumption of energy and cutting its emissions
25	of greenhouse gases, requiring an energy efficiency

2	report to be filed every five years rather than every
3	decade will encourage closer monitoring for operators
4	and increase the data driven knowledge of buildings
5	throughout our city; I ask my colleagues to sign onto
6	this intro as well. Thank you.

8	Council Member Williams.
9	COUNCIL MEMBER WILLIAMS: Thank you
10	Madame Public Advocate. I'm sorry; I walked in the
11	middle of Council Member Cumbo's remarks, but I'm
12	sure I'd like to attach myself to them from what I
13	heard and Council Member Gibson, a couple of weeks
14	ago obviously as we pay attention to the horrors that
15	happened in Paris, I can see much about it on CNN,
16	but I did not see much about the 2,000 people who
17	were slaughtered in Nigeria and if we have come to a
18	place that 17 people do not equal 2,000, it's very
19	disturbing, so hopefully we remember the atrocities
20	that happen all across the world.
21	I'd like to call my attention to Int
22	0639, sponsored by myself, Torres, Lancman, Johnson,
23	Wills and Gibson, it's a local law to amend the
24	Administrative Code, requiring the Police Department
25	to make quarterly reports relating to the issuance of

3	Slope, they averaged eight bike summonses a year; in

7	number of criminal court summonses issued for each
8	patrol precinct, housing police, service area
9	transit, district street crime unit and the narcotics
10	division of the number of criminal court summonses
11	issued, not including any situation where the
12	arrestee is transported to the precinct broken down
13	by race, of suspect gender, age of the suspect and
14	the offense charged including but not limited to
15	marijuana violations. I believe there's a
16	conversation that has to continue in this body, not
17	just for the people of the City of New York, but for
18	the rookies that we clapped here for today. As we
19	spoke of Dr. Martin Luther King, he said on some
20	positions cowardice asked a question, is it expedient
21	and then expedience comes along and asks the question
22	is it politic; vanity asks the question, is it
23	popular, conscience asks the question is it right;
24	there comes a time when one must take the position
25	that is neither safe, nor politic nor popular, but he

3	I hope we help this conversation move forward with

9	to Int 0623. How many times have we had constituents

14	get out a ruler or tape measure and to measure the
15	space between the hydrant and the car. It's because
16	the curbs are not painted the way they should to
17	indicate the space that is the legal space for
18	hydrants and obviously for bus stops. So Int 0623
19	would require that the spaces in which a motorist
20	cannot park in a bus stop or in front of a fire
21	hydrant be clearly marked with red paint so that
22	drivers can follow the law and not be subject to

19	0550, which urges the New York Power Authority to set
20	a permanently competitive rate for shore-based
21	electrical power at the Brooklyn Cruise Terminal.
22	When cruise ships dock at the Brooklyn Cruise
23	Terminal they continue to run their engines in order

24 to provide electricity onboard; the fuel that they 25 use considered one of the worst for releasing air

8	and New York, the Environmental Protection Agency,
9	Conover Group and the New York Power Authority [bell]
10	have all contributed to building shore power capacity
11	at the Brooklyn Terminal and so we're asking New York
12	State to give them a permanent sustainable Con Edison
13	rate so that they can stop using this horribly
14	polluting fuel. Thank you. [crosstalk]
15	PUBLIC ADVOCATE JAMES: Thank you.
16	Council Member Cabrera.
17	COUNCIL MEMBER CABRERA: Thank you so
18	much. I've been Israel three times; I know next
19	month there's gonna be a trip with Council Members
20	going; I will not be part of that; Madame Speaker,
21	please consider me for next year, but I will be going
22	to Israel next month and I wanna let my Jewish
23	brothers and sisters know that I'll be going with a
24	group of the largest pro-Israel Christian group in
25	the United States in support of Israel. The fact of
