morning, [background comments] joyous morning; the
gold star goes to Dylan this morning. [background
comments].

6 So good morning; I am Donovan Richards, 7 Chair of the Subcommittee on Zoning and Franchises; 8 we are here continuing our meeting that was recessed 9 on Tuesday, January 12th. We are joined today by 10 Council Members... okay, Jumaane Williams, Ritchie 11 Torres, Inez Barron ... Okay, here, he gave me the list 12 so I get it right. Alright, Council Member 13 Garodnick, Gentile, Williams, Reynoso, Torres, 14 Matteo... what is this? [background comment] Oh ... 15 [background comment] okay, Barron, Dickens, Palma, 16 Greenfield.

Today we'll be considering five items on the agenda -- Land Use Item Nos. 0315, 0316 and 0317, all sidewalk cafes in Council Mendez' district. The council member supports these cafes.

Then we are moving on to Land Use Item Nos. 0321, 521-529, Durant Avenue, an application to modify the text of the zoning resolution to eliminate 13,362 sq. ft. of designated open space in Special South Richmond Development District. This action 1 SUBCOMMITTEE ON ZONING AND FRANCHISES 2 would facilitate the development of these two-family 3 homes. This item is in Council Member Borelli's 4 district and the council member supports this 5 application.

Next, Land Use Item Nos. 0322, 0323 and 6 7 0324, Landmark Colony in Council Member Matteo's district. This application includes a text amendment 8 9 concerning the bulk parking, grading and private road regulations, a Zoning Map amendment to establish a 10 11 C1-3 district on a portion of the property and a disposition of City-owned property. These actions 12 13 would facilitate the development and rehabilitation 14 of the New York Farm Colony, a landmark property with 15 historic buildings that will be repaired by the 16 developer. The property will be developed with 344 17 units of age-restricted senior housing; the property, 18 once again, is in Council Member Matteo's district 19 and he has indicated his support for this 20 application.

We also have two cafes that have been 21 withdrawn, Land Use Items 0299 and 0300; we will be 2.2 23 voting to remove these items from our calendar. Lastly, we will be laying over two items 24 until the next regularly scheduled subcommittee 25

COUNCIL MEMBER TORRES: Just permission 13 14 to explain my vote. I just wanna commend Council 15 Member Matteo; the site has obviously been chronically vacant for 40 years, so it speaks to your 16 17 leadership that you were finally able to get it done. 18 So with that said, I vote aye. 19 COMMITTEE COUNSEL: Land Use Items 0315, 0316, 0317, 0321, 0322, 0323 and 0324 approved with a 20 vote of 6 in the affirmative, 0 in the negative; 0 21 abstentions, with the exception of Land Use Items 2.2 23 0322, 0323 and 0324, which were approved with a vote of 5 in the affirmative, 0 in the negative and 1 24 25 abstention, and motions to file Land Use Items 0299
