3 CHAIRPERSON LEVINE: [gavel] Good 4 morning, everybody. We're going to get underway. 5 I'm Mark Levine, Chair of the City Council's 6 Committee on Parks and Recreation. Today, we have two 7 matters that we'll be voting on. First up is 8 proposed Intro 856-A, the bill that would require the 9 Parks Department to created discounted membership 10 fees at its recreation centers for seniors, youth, 11 veterans and person with disabilities. We are also 12 going to be voting on our Semi-Annual Street Co-13 Naming Bill, which will ceremonially name 42 14 thoroughfares and public places throughout the city. 15 I'm going to say more on both of these items shortly, 16 but we're going to kick it off with testimony from 17 two public witnesses who have asked to speak, and so 18 I'd like to ask Sarah Fisher, and Jacob Morris to 19 please come on up. [pause] Sergeant, if you could 20 just put it--we'll put a five-minute on the clock. 21 Yeah. [pause] All right, welcome to you both. 2.2 Sarah, if you're ready, you can kick us off. 23 SARAH FISHER: [off mic] 24 CHAIRPERSON LEVINE: All right, Jake is 25 readv. Jake, was born ready. [laughter]

2 JACOB MORRIS: Oh, wow. Yeah, this is good quality. So I'm very happy today. I'm happy 3 4 because as I was sitting here waiting for the hearing 5 to start, this nice lady sitting next to me was 6 looking over the proposed names in the -- in the co-7 name package, and when she said, Gee, there's some nice names in the package--the sign--I--I would like 8 to live on Hip Hop Boulevard. [laughs] in particular 9 and that--that really made my morning. 10 It's been-it's been a long time coming for Hip Hop Boulevard. 11 12 I first proposed the name in 2007, and this was after Sunny Carson, the controversy over Sunny Carson. You 13 know, because that's where well Sedgwick especially 14 1520 Sedgwick was where Kool Herc had the first hip 15 16 hop party, which is historically acknowledge and--and the location of 1520 Sedgwick is--it is on the State 17 18 Registry of Historic Places. And so, you know, I was doing a lot of street co-naming in Harlem in 19 20 particular and a district manager in Harlem told hey, you know, could you take a look at the Bronx, Jacob, 21 2.2 because you're good at this. [laughs] And so I said 23 well, you know, they changed the guidelines. You've got to be dead. [laughs] So to name it after Kool 24 25 Her, you know, and then there might be some rivalries

2	involved with the founders of hip hop. So I said but
3	if you name it Hip Hop Boulevard then everybody gets
4	celebrated who was involved with the founding of hip
5	hop. And so that's how the name cam about, and it
6	really resonated with a lot of people. There's been
7	television coverage about the name ofthey had three
8	hearings in Community Board 5 in the Bronx on this
9	and community was like gee we should have did this a
10	long time ago. [laughs] So, this is the culmination
11	of a long, long road with jumping through many, many
12	hoops and many, many obstacles, but here we are in
13	2016, andand it's going to come before your
14	committee, and hopefully it will pass with all the
15	other proposed namings and then get voted by the full
16	City Council and signed by Mary de Blasio, andand
17	we will have an absolutely wonderful celebration, and
18	[coughs] I got to say here in New York City, and
19	especially the Bronx this honors the Bronx. I mean
20	Hip Hop is a worldwide phenomenon. And it's not just
21	the music. It's not just the music. The music
22	talking over the beat, you know, that'sthat's where
23	it happened whether it's fashion, it's dance, it's
24	art, it's a multiplicity of creating endeavors, and
25	it's inspired our youth andandand our entire

2	society. It's given a liveliness and a ferment to
3	our entire society. Hip Hop that it started here in
4	this unique mix ofof what was going on in the Bronx
5	in the early 1970s, it's just very, very special.
6	So, I thank you. I want to thank you very much
7	CHAIRPERSON LEVINE: Thank you, Mr.
8	Morris. Thank you for your advocacy and your
9	testimony today. Sarah, please.
10	SARAH FISHER: [off mic] Hi, I'm here to
11	speak on I think it's
12	SERGEANT-AT-ARMS: Your mic, please.
13	SARAH FISHER: [off mic] Is that in here?
14	JACOB MORRIS: Yes.
15	CHAIRPERSON LEVINE: Andand while
16	while you fumble for that, I do want to acknowledge I
17	forgot to acknowledge that we have colleagues here in
18	the room I want to thank for being here. We have
19	Council Member Gibson from the Bronx, and we have a
20	special guest from the Parks Committee today, Council
21	Member Cohen also from the Bronx and Council Member
22	Mealy from Brooklyn. I'm sure I'll be hearing from
23	the shortly, and please proceed.
24	SARAH FISHER: Great. My name is Sarah
25	Fisher. I'm the Co-Founder of Friends of Inwood Hill
	I

2	Park, which if you don't know it is the most
3	beautiful park in Manhattan, and also our last
4	natural forest and salt marsh, and also a member of
5	Fountain House for the last ten years. The reason I'm
6	here is to ask you to consider a slight important
7	amendment to $856-A$, and that is tois to consider
8	adding not just recreation center membership fees,
9	but also tennis permit fees to the bill. And if I
10	can find my copy. I testifiedI tried to get here
11	actually for the hearing that you had in October,
12	another rainy day actually rainier than this, and I
13	got here. I think it was a quick hearing, and I get
14	here a few minutes late, enough time to hold an
15	umbrella in front ofover Edith and the person who
16	was here from Parks. The reason I ask, and think
17	that this is a logical changeand I find the
18	language in a minuteis I think it's also logical to
19	the Parks Department. When they raise the tennis
20	fees initially a few years ago, when they double the
21	fees, it was not only doubling those fees for
22	recreationrecreation centers, but also for tennis
23	courts. And, in fact, their rule that they proposed
24	and adopted was towas a reduction of fees for
25	recreation centers and tennis permits for people who

2	help this cause. So they just proposed a rule and I
3	can read the language of it. They said the purpose
4	of itthe purpose of the rule is to enhance access
5	to recreational opportunities for New York residents
6	at the Parks Departmentssorry, I'm reading on a
7	phonerecreation centers and tennis courts. The
8	rule will establish a new reduced membership fee and
9	a reduced tennis permit fee for adults with a valid
10	New York City Identification NYIDC card. I think
11	that the language that you all have it could be
12	adopted pretty quickly by inserting a few words. And
13	what I would say is I liveif I can find the words
14	to write and then yes I can give you specific
15	language that I would suggest. But IInwood Hill
16	Park does not have a recreation center. We do have
17	tennis courts, and we would like to increase access
18	to those tennis courts forfor veterans and for
19	people with disabilities. The language in the
20	proposed law would just be an addition of a few
21	choice words, discounted recreation center, and I
22	would add after that and tennis permit fees. The
23	next sentence annual membershipannual recreation
24	insert the word recreation center membership fee and
25	tennis permit fees for each recreation center and
I

2	tennis court under the jurisdiction of the department
3	shall be reduced for a person 62 years of age and
4	older. Persons between 18 and 24 years of age,
5	veterans and persons with disabilities. Such reduced
6	fees hall be no greater than 25% of the highest
7	annual member and tennis permit fees charged at such
8	recreation centers and tennis courts. I think it's
9	a logical change. I think that it would make sense
10	to the department. When they make adjustments to
11	their fee schedules, those are the two they always
12	adjust together, and I see no reason why this
13	committee and the City Council cannot consider both.
14	CHAIRPERSON LEVINE: Thank you, Sarah,
15	for your advocacy on this. This bill is already
16	begun the aging process for voting on Friday.
17	SARAH FISHER: Right.
18	CHAIRPERSON LEVINE: So, we're not able
19	to amend it a this late date, but you make a very
20	compelling case on tennis fees. I think it's
21	something that this committee should take up as
22	future legislation. So, I'm happy you brought it to
23	our attention, and thank you for speaking out today.
24	We are still waiting for quorum. So, my colleagues,
25	Council Members Mealy and Cohen are going to be

1 COMMITTEE ON PARKS AND RECREATION 10 2 locked in their seats with me for a little bit, but I would like to ask Council Member Gibson, because she 3 may have a busy day, if you would like to speak at 4 5 all. I believe--is Hip Hop Boulevard in your district? 6 7 COUNCIL MEMBER MEALY: [off mic] Yes. 8 CHAIRPERSON LEVINE: Is that right? Okay, well, if you'd like to say a few words on that, 9 10 please. COUNCIL MEMBER GIBSON: Thank you 11 Sure. 12 and good morning Chair Levine, and to all of my 13 colleagues on the Parks Committee. Thank you for the 14 warm welcome. I truly appreciate it, and I know 15 before us is legislation that will rename and co-name 16 several thoroughfares throughout the City of New 17 York, and I just wan to in addition to Hop Hop 18 Boulevard, speak very quickly about a few others that are very important to me. Obviously, we're going to 19 20 rename a section in Far Rockaway in honor of fallen NYP Detective Randolph Holder, who was a Housing cop 21 2.2 in PSA-5 who was unfortunately killed just several 23 months ago, as well as honoring Carey Gabay, who was one of the counsel that worked for Governor Andrew 24 25 Cuomo, very important as well. In my district in the

2	Bronx, we're also honoring a dear friend of mine who
3	was one of the founders of the Morris Heights Health
4	Center, Loretta Ruddock Smith was a community
5	resident of Community Board, very, very active. So
6	much that we did in Community Board 5, and I'm truly
7	honored that we're going to re-name the street that
8	she lived for over 30 years in my district in her
9	honor. I also want to recognize Dr. Derrick E.
10	Griffith Way, who was a professor at Medgar Evers
11	College. Although he had a Brooklyn nativity, he was
12	from the Bronx, lived, born and raised, and certainly
13	was the founder or CUNY Prep School. Which is a
14	program that provides young people an opportunity to
15	ascend for college. So I'm very proud of that, and
16	obviously Hip Hop Boulevard is extremely important to
17	us in the Bronx. We know that there's been a lot of
18	talk, but we always say that Bronx has and will
19	always be the birth place of Hip Hop. It is
20	recognition. It is an acknowledgement of the work
21	that hip hop has done, the contributions, the value
22	it has brought to the music industry to up and coming
23	artists, all of the incredible trailblazers and
24	pioneers in Hip Hop history, DJ Kool Herc, Grand
25	Master of theatrical (sic) whiz; Melly Mel and

2	Grandmaster Caz. I can name them all because many of
3	them I know, and I've been working with. Because
4	renaming 1520 Sedgwick Avenue where DJ Kool Herc
5	Herc's first scratched andand started his DJ
6	skills in the community room. We have had a major
7	transformation at 1520, and I'm very proud. The new
8	owner's workforce advisors have renovated the
9	building. We have had to support all the way up to
10	Senator Chuck Charles Schumer, and we had a wonderful
11	opening about a year and a half go. And DJ Kool Herc
12	returned, him and his sister, and it was really for
13	us just-it was memorable. And this is certainly
14	attributed to all that we have done in the Bronx to
15	recognize that no matter where you go in this
16	country, Hip Hop is a part of the fabric, and it
17	started in the great borough of the Bronx. And I'm
18	very proud that 1520 will not only stand out in that
19	way, but this is a part of a much bigger plan that we
20	have in the Bronx to finally create the first ever
21	hip hop museum. Because we want to have cultural
22	institutions that recognize the growth, and the value
23	of hip hop, not just from the perspective of the
24	Bronx, but the entire city. And so, we have been
25	working with all stakeholders including Windows of

2	Hip Hop, an incredible group led by Melissa Libran
3	and Jacob Morris. I thank you for your tireless
4	efforts. Not only have you been extremely consistent
5	to coming to hearings, but you have really made a
6	difference in Community Board 5 to get them on board
7	to be supportive, and making sure that 1520 is
8	renamed Hip Hop Boulevard. So I'm very proud of
9	this. I know it's a long time coming, but with any
10	struggle, there's always strength, and certainly we
11	always have the right vision. We just have to get
12	there. So I'm thankful for the support of my
13	colleagues, and I know that my wonderful members of
14	the Parks Committee I hope you will certainly support
15	this because for us we struggle often to look at
16	positive images of the Bronx. And everyday we strive
17	as elected officials, as residents to make sure that
18	we portray positive images of the Bronx because we
19	are on a renaissance. We are on the cusp of economic
20	development that is going to transform our borough.
21	And I believe hip hop is a significant part of that.
22	So I'm very proud to represent this district. I live
23	in Morris Heights. I'm not too far from 1520
24	Sedgwick Avenue. So I look forward to a wonderful
25	event, and certainly every time I'm at 1520 I will
I	

1 COMMITTEE ON PARKS AND RECREATION 1 2 always remember that it is and will always be the 3 birthplace of Hip Hop. Thank you very much, Chair 4 Levine.

5 CHAIRPERSON LEVINE: Thank you Council 6 Member Gibson for your very eloquent statement on 7 this topic. I'm going to take a moment to talk about the piece of legislation that we are hopefully voting 8 on shortly. Intro 856-A, which as has been mentioned 9 earlier would provide discounted fees to our 10 recreation centers for important populations in New 11 12 York City. There are 35 recreation centers all--in all five boroughs, and they provide everything front 13 indoor basketball courts to indoor pools, art 14 15 studios, after school programs, weight rooms, dance 16 studios, yoga studios, even libraries. And they are--they are just an incredible resource for New Yorkers 17 18 who want to live healthy, and want to enjoy social interactions of a positive nature with their 19 20 neighbors. We think that they are particularly important for two groups: Veterans and people with 21 disabilities who themselves often are involved in 2.2 23 physical rehabilitation regimes that can--regimens that can benefit from access to recreation centers, 24 25 and groups that can benefit from the social

2	interaction, which rec centers provide. Because too
3	often seniors and peopleveterans and people living
4	with disabilities are socially isolated, but there's
5	a challenge her and it's economic. The averagethe
6	current membership for rec centers is \$150, and that
7	is out of reach, \$150 a year. It's out of reach for
8	many people who are struggling economically. It
9	turns out that among our veterans, the Food Bank of
10	New York City estimates that 70,000 veterans, about
11	30% of the total population every year turns to food
12	banks, soup kitchens, food pantries, an indication of
13	the poverty that so many are struggling with. And
14	among people with disabilities, the unemployment rate
15	is 30%, more than double what it is for the general
16	population. We don't want people who are struggling
17	economically who so desperately need the services
18	that they can access, you know, recreation centers to
19	be blocked because they just can't afford the
20	membership. So our bill, Intro 586excuse me856-A
21	would provide an 80% discount in these fees so that
22	it will be \$30 instead of \$150, and far more
23	accessible to the average New Yorker. My colleagues
24	on the committee will remember this is the bill we
25	discussed a few months ago. There has been, as it

2	sometimes happens, there's been no watering down in
3	our negotiations with the Administration. In fact, a
4	rare thing has happened. The bill has gotten even
5	better and stronger since we heard this several
6	months ago. We are now codifying in this legislation
7	discounts for youth and seniors. So all four of
8	these groups, veterans, people with disabilities,
9	youth and seniors will have in this legislation a
10	discount of 80% off the standard fee, an 80% discount
11	on a fee that's currently \$150. We just feel great
12	about this bill, and what it will do for populations
13	which are so badly in need of access to these
14	wonderful resources. I'm going to pause there, and
15	see whether either of my colleagues on the committee
16	have comments on street renaming bills. If you
17	don't, I have some of my own. Council Member Cohen,
18	any comments for your street names?
19	COUNCIL MEMBER COHEN: [off mic] I'd like
20	to help you build another one. (sic)
21	CHAIRPERSON LEVINE: [laughs] No
22	problem. Council Member Mealy take it away.
23	COUNCIL MEMBER MEALY: Yes, thank you,
24	Chair. I see that my colleague is not here, Laurie
25	Cumbo, but I just wanted to say I'm thankful that

2	youwe doing the street name of Reverend Clarence
3	Norman, Sr. He's the father Clarence Norman, Jr. who
4	used to be our Democratic leader of King's County,
5	and this waswe called him the Lion King in our
6	area. He's strong, pastor of his church. His church
7	has 2,000 members, still strong, and just recently,
8	his wife passed away also. So it'sit's sad and
9	it's rewarding also that we are acknowledging him
10	right away. So I just want to thank this body for
11	puttingand my colleagues for putting their name
12	forward, and I hope this body votes unanimously on
13	this. This is a street name that is worthy of the
14	esteem of all of this great city of New York, and I
15	thank you for Reverend Clarence Norman, Sr. Way.
16	CHAIRPERSON LEVINE: [interposing] All
17	right.
18	COUNCIL MEMBER MEALY: Thank you.
19	CHAIRPERSON LEVINE: Thank you, Council
20	Member. I'm pleased to be introducing street co-
21	namings for two locations in my district named after
22	two incredible people. The first is we are creating
23	Normal Rockwell Way at 101st Street and Broadway.
24	Now, who knew that this American icon wasn't from the
25	corn fields of Iowa. He was from 101st Street right
	I

2	on the west side of Manhattan. He was born there.
3	He was raised there. He famously trained at the Art
4	Students League in Midtown. He actually began
5	painting at a young age, and even received
6	commissioned works while still living in New York
7	City. Now, he is known worldwide for his depictions
8	of everyday life in rural America, but those of you
9	who are more familiar with his work know he did
10	incredibly powerful paintings chronicling the Civil
11	Rights Movements, the very famous set of paintings
12	that depicted for four freedoms enunciated by
13	President Franklin Delano Roosevelt. This is a man
14	with a profound social consciousness, and I can only
15	imagine that living in the bustling diversity of
16	101st Street in the early 1900s where he would come
17	across people from all walks of life, all ethnic and
18	racial backgrounds, people of all economic levels
19	that that had a profound impact on this young child.
20	So I think it's so powerful that we commemorate his
21	roots on 103rd Street. I wish I could take credit
22	for uncovering this delicious historical morsel, but
23	neither I nor any elected official, nor for that
24	matter any historian or art expert can take credit
25	for this street co-naming. It was students at West

2	Side High School, rightjust a few blows away,
3	students who brought this to the attention of my
4	office, to the attention of the City Council. And
5	it's thanks to them that we're going to be
6	commemorating this important historical link that I
7	hope will make 103rd Street a destination for art
8	aficionados, and historian globally to come see the
9	neighborhood that created this American icon. Hard
10	to top that one, but I do have one more street co-
11	naming in my district on 155th Street and Amsterdam
12	Avenue for the Reverend Dr. Jasper Simmons, who was a
13	pillar our community's religious and cultural life,
14	who was the longest serving pastorwho's known as
15	having been the longest serving pastor in the Tri-
16	State area. After founding the File Chapel Baptist
17	Church, and serving that fine institution and so many
18	other community organizations. We are now going to
19	pause for a few minutes as we await a quorum before
20	we take votes on Intro 586-A and the street co-
21	namings throughout the city. Thank you all for being
22	here. Stay tuned as we await a quorum and vote on
23	these important matters. If anyone knows any good
24	jokes, now would be the time to use them. [pause]
25

Council Member Maisel. 19 20 COUNCIL MEMBER MAISEL: [off mic] I'm in favor. 21 The final vote now Committee on 2.2 CLERK: 23 Parks and Recreation stands at 6 in the affirmative, 0 in the negative and no abstention. 24 25 [pause]
