2	CHAIR MEALY: Good afternoon we are about
3	to start this Committee on Civil Rights. I'm Darlene
4	Mealy, I am the Chair of the New York City Council
5	Committee on Civil Rights. I'd like to introduce the
6	other members of the Council who have joined us this
7	afternoon. Council Member King, Council Member
8	Dromm, Council Member Mathieu Eugene. Today the
9	Committee on Civil Rights will vote on resolution
10	1000. A resolution recognizing March 5^{th} as Three
11	Fifths Clause Awareness Day to be officially observed
12	each year in New York City and proposed resolution
13	1001A, a resolution calling upon Congress to add an
14	amendment to the Constitution of the United States
15	directly negating the language of article 2,
16	paragraph 3 known as the Three Fifths Clause. Both
17	of these resolutions are sponsored by Council Member
18	King. We've received a lot of positive feedback on
19	these resolutions at our hearing on April $18^{ ext{th}}$ and we
20	are proud to move forward with taking the steps to
21	secure a long lasting negative effects on the Three
22	Fifths Clause. Thank you Council Member King for all
23	the leadership and efforts you have put into this
24	legislation. I'd like to also thank the advocates
25	who testified on these two resolutions. Finally I

2	want to thank you to the Civil Rights Committee staff
3	or their hard work; Alesha Brown, Council to the
4	Committee and to Ms. Casey Addison, Policy Analyst in
5	the Government Affairs division. Now we will turn
6	this Council, we will turn it over to Council Member
7	King who Sponsored these resolutions that we will be
8	voting on today and just thank you for all hard work
9	you have done on this legislation and make sure that
10	people understand that and March 5^{th} can become a day
11	that we all will recognize. I turn it over to
12	Council Member King.

COUNCIL MEMBER KING: Thank you Chair 13 Mealy. I want to first thank you for hearing the 14 15 conversation that I've had with you and the rest of the Council Member in regards to importance of 16 17 understanding history. I want to thank the Committee and Council Alesha Brown, Alesha Brown I get it right 18 19 as well and Casey Addison. After a number of conversations of verbiage and understanding the law 20 as it pertains to the United States Constitution. 21 The Constitution which was founded and put together 2.2 23 for the delegates in the 1787 convention, there was a determination of how we treat all of humans at that 24 25 time and at that point the slave in America which we

know over 90% was the black in America was considered 2 3 3/5 of a human being for... for the goal of taxation 4 and but more importantly to get representation throughout the union and Washington but still that 5 same language today that call that black in America 6 7 3/5 of a human being I really believe the philosophy in all of its legacy from this language is still 8 9 prevalent today on how policy is shaped, how finance are delivered or just how the relationship between 10 11 human beings are at an existence. Some at a good 12 rate, some at a horrible rate and I think that in order for us to fix it we have to tackle the root of 13 14 the virus and I believe the cancer of bad rate 15 relationships between anybody in the black community 16 because it is the black. I don't want anybody to get 17 confused that slavery even though there were some 18 people who were involved in slavery that might have 19 The majority of slaves were black, been non-black. 20 just like the holocaust belong to the Jew, no one can't claim slavery other than the black in America. 21 2.2 So I don't want anybody to get confused that this 23 language that this resolution that I'm calling on the Three Fifths Clause Awareness today is just to remind 24 everybody of the history of America and that the 25

Three Fifths conversation our children in schools 2 3 need to understand it. Need to understand that the Emancipation Proclamation didn't free the slaves but 4 it was the 13th amendment that made slavery illegal 5 but however, unless you are still incarnated you are 6 a slave and that the 14th amendment gave blacks who 7 are if you were born in this Country, it a gave you 8 9 the power and the protection and the privileges under the Constitution and the 15th amendment gave blacks 10 11 the right to vote. All of these amendment have superseded the Three Fifths Clause compromise but not 12 out of all three of them, none of them have ever 13 14 addressed to saying that that slave that was 15 considered 3/5 is considered a whole person so I am truly grateful and thankful that today we've had 16 17 this... were having this vote today, I'm thankful and 18 grateful of the conversation that we've had the hearing on the 18th and those who testified to 19 20 understanding that in order for a progressive society claims as truly progressive that the root of it's 21 founding piece of paper should be reflective of how 2.2 23 we have transformed and move or society forward and in any language that negates our ability to so should 24 be stricken from the record or at least there should 25

2	be conversation that amends it and that's what I'm
3	asking for and I'm asking Congress to amend the
4	United States Constitution to negate any language of
5	the Three Fifths compromise by saying that the black,
6	that slave is 100% whole, so Council Member and Chair
7	Mealy I want to thank you and all my colleagues today
8	who are for the vote, understanding how important
9	this piece of legislation is not only just to the
10	black community but to making all United States whole
11	and I urging everyone everyone here today to vote
12	yes. Thank you again Madam Chair.
13	CHAIR MEALY: Do any of my colleagues
14	have any statements.
15	COUNCIL MEMBER DROMM: Thank you very
16	much Chair Mealy and thank you Council Member King
17	for this wonderful piece of legislation and you know
18	the hearing that we've had a couple of weeks ago I
19	guess it was now, I found it to very educational and
20	informative. You know I'm ashamed to say almost that
21	I was a Social Studies Teacher and did not know too
22	much about the Three Fifths Amendment and can't
23	really recall actually introducing it in my classroom
24	at that time. So by having this resolution I thing
25	it highlights a piece of history that the world

should also be ashamed of and at the hearing you know 2 3 I raised the question about why can't the language be stricken from the constitution and then I went 4 upstairs and spoke to my staff attorney and realized 5 you can't just strike things from the constitution 6 7 United State of America, so adding the words to negate it I think is very purposefully but it also 8 9 serves as purpose that the language is let there so that we can continue to educate people about the 10 11 history of the struggle of African Americans in this 12 Country and I am a true believer in that those who 13 forget history are doomed to repeat it and so having 14 that piece in there may serve that purpose well so 15 that we never again repeat this phase in American 16 History in our lives or any lives of any Americans in 17 the future, so thank you for this legislation, thank 18 you ... thank you Chair Mealy, Alesha Brown too, thank 19 you for all your work on this ... on this effort. 20 CHAIR MEALY: Thank you we've been joined 21 by Salamanca who is part of this Committee (inaudible). Ok and I concur with you that we will n 2.2 23 ever forget and I'm have the clerk do the roll call. COMMITTEE CLERK: Committee Clerk, 24 Matthew DeStefino, Committee on Civil Rights, roll 25

2 call on resolution 1000 and resolution 1000A, Chair3 Mealy.

4 CHAIR MEALY: I vote aye on this historic legislation and I hope our young people realize and 5 go look it up and see exactly what the law saying in 6 this Constitution of United States of America in the 7 21st Century. So I'm honored and thank you Council 8 9 Member King for taking a lead on this and being bold about it. Everyone... some people really saying they 10 11 really don't want to be associated with this It's black and 12 legislation but it is what it is. white, it's in the amendment and it's in the 13 14 constitution and it haven't changed so my colleague, 15 thank you. If we don't, people will forget their 16 history so I'm kind of glad it will stay there for a 17 minute that people can look it up and make sure that 18 they never forget and never repeat, so I vote aye on 19 this great legislation, thank you. 20 COMMITTEE CLERK: Eugene. 21 COUNCIL MEMBER EUGENE: May I explain my 2.2 vote. I just want to commend the Chair Mealy for 23 your leadership and I want to thank the Council King also for this wonderful piece of legislation, this is 24

history and I thank it is not about slavery or slave

3	and I thank you have corrected a big, big, big you
4	know mistake and we done in this history, history you
5	cannot, there's nothing we can do about that, this
6	that will bring something that everybody, everyone
7	who got this other ethnicity and ethnic background
8	and faith and religion should be proud of those
9	(inaudible) America another dimension and then when
10	we see that all men are created in our equal, this
11	piece of legislation you know is a monumental,
12	historic in a piece and I think that you know this is
13	a wonderful thing I'm proud to vote yes and thank you
14	Council Member King, thank you.
15	COMMITTEE CLERK: Dromm.
16	COUNCIL MEMBER DROMM: I'd like to ask
17	that I be added as a co-sponsor if I haven't done
18	that already and to also vote yes.
19	COMMITTEE CLERK: King.
20	COUNCIL MEMBER KING: Before I vote I
21	just want add to the record that I am not $3/5$ of a
22	human being, I'm 100% whole and if anyone ask you if
23	you are 100% whole, that will remind you that Jesus
24	doesn't make any mistakes and I vote aye.
25	COMMITTEE CLERK: Salamanca.

2	COUNCIL MEMBER SALAMANCA: I vote aye on
3	all and I want to congratulate Council Member King on
4	number one educating myself and my family on this and
5	thank you for really speaking out in terms of
6	addressing something that many of us did not know
7	that really existed there so I congratulate you on
8	your hard work.
9	COMMITTEE CLERK: By a vote of 5 in the
10	affirmative, 0 in the negative and no abstentions,
11	the resolutions have been adopted.
12	CHAIR MEALY: I want to thank all my
13	colleagues for being here today and just imagine some
14	of our congressional districts would change if the
15	put this law correctly. It goes so far back that if
16	we count we would get some of these congressional
17	sits back also, so with no further due, thank you for
18	this legislation, thank you colleagues and this City
19	of Civil Rights Committee is adjourned.
