2 CHAIRPERSON MILLER: Good morning, I'm 3 Council Member I. Daneek Miller. I'm the Chair of 4 the Committee on Civil Service and Labor. Today we 5 are voting on technical amendments to Introduction 6 1011A which once signed into law will expand worker 7 protections to those in the food service industry. 8 This bill expands protections we have given to 9 displaced building workers in 2002 so that these 10 individuals know that will not lose their job because 11 of factors that are beyond their control. These 12 amendments will mandate that the new owners and 13 employers retain current food service workers for 90 14 days transition period, giving them time to evaluate 15 their needs and for their employees to find new employment if necessary. When we held a hearing on 16 17 this bill in November of 2015, we heard from elected 18 officials, advocates and labor organizations all in 19 favor of this law. That is because it is not just 20 good sense for workers and worker protection, but it 21 is also good for management who will have experienced 2.2 staff on hand and for the communities that they 23 That is why 31 of my fellow Council Members serve. 24 have signed onto this legislation, and I am proud to 25 be voting in the affirmative today.
