13	Program. The Council Member, Dickens, is supportive

16	considered Resolution sets forth December 15th, 2016

10	specific information regarding the proposal can be
11	found in the Committee report prepared by the Finance
12	Division with an attached City Planning Commission

15	I'm now going to ask Billy Martin, the Committee
16	Clerk, to call the roll, and prior to giving your
17	vote, I'm going to ask you to say the increase in the
18	dollar amount of the assessment on the bid, okay? So
