3 CHAIRPERSON MEALY: Good morning. I**′**m 4 Darlene Mealy. I am the Chair of the New York City 5 Council's Committee on Civil Rights. I would like to 6 introduce other members of the Council who have 7 joined us this morning, Andy King and Council Member 8 Today, the Committee on Civil Rights will Dromm. 9 vote on Intro 1253-A, a very important piece of 10 legislation that will prohibit employee from-11 employers from inquiring about or-or replying-I'm 12 sorry-inquiring about or relying on a kin(sic) mate's 13 salary history to determine their compensation. 14 Studies show that salary history can have a negative 15 effect on employees particularly women, and this is 16 Women's History Month. So you know three days, four days afterwards, and please know that Women's History 17 18 Month is everyday, 365 days. By keeping salaries low 19 throughout their career, when employers rely on prior 20 salary histories to determine compensation, they 21 contribute to a gender wage gap. Intro 1253-A would 22 help break the cycle of pay inequity by reducing the 23 likelihood that women will be prejudiced by prior 24 salary. Thanks to the Public Advocate Tish James 25 who-for introducing this important legislation.

2	Thanks to the Civil Rights Committee staff and their
3	hard work, Dee Emanuel, Counsel to the Committee;
4	Dali Mi Ha Ring (sp?), Legislation Counsel; Sheila
5	Johnson in Finance; Rachel Cordero, Deputy Director
6	of Government Affairs Division; and Matt Gewolb,
7	Director of Legislation. I hope that my fellow
8	committee members will support this bill today so we
9	can have a vote on Wednesday at the Stated Meeting.
10	Thank you for making the time to vote on such
11	important legislation. Our Public Advocate she did
12	want to have a say-a statement, but we going to go
13	ahead with the vote until she comes, of if she do not
14	come, and Elizabeth Crowley also would like to have a
15	statement on this legislation, but for now, I'm going
16	to turn it over to our-

CHAIRPERSON MEALY: Yes, you may.

5 COUNCIL MEMBER KING: First, I want to add my voice as well as the co-sponsor of this piece 6 7 of legislation. For our sisters, mothers, brotherssisters, mothers and aunts and friends who work 8 9 tirelessly in New York City to help improve our homes and our community, it just doesn't make sense that 10 11 over a period of time we haven't figured out how to make sure that our women are able to continue to 12 13 provide for their families each and everyday. I 14 think this piece of legislation is one that makes New 15 York again a leader in making sure that there is pay 16 equity for all or everyone, and I'm thankful to you, 17 Madam Chair, for just being here along with the Public Advocate and all the Council Members who have 18 19 signed on, and there's no way we don't pass this and 20 change the rules of how our women are not getting 21 paid as well as those of color who-who have 2.2 experience through negative impacts of salary. 23 Someone should be paid for their work not based on their sexuality or their ethnicity. So again, I say 24

3	together, and I vote aye.
4	CLERK: By a vote of 3 in the
5	affirmative, 0 in the negative and no abstentions,
6	the item has been adopted by the committee.
7	CHAIRPERSON MEALY: And may I say we have
8	to think about today as national equal Pay Day for
9	women. So, please-I believe we supposed to wore red
10	or a little red in there. So thank you, Andy King
11	for just saying that because it is important for us
12	to get equal pay, and never be discriminated against,
13	and we know men are being paid more than women. So
14	we hope that that can change with this legislation,
15	and we are going to leave this vote open for 20
16	minutes for other colleagues to come and vote, and we
17	will hear a statement if our colleague, Elizabeth
18	Crowley come, and our Public Advocate Tish James, and
19	I thank my colleagues for being here. [pause]
20	[background comments] Both colleagues. Well, Andy
21	King, do you want to add some words to it?
22	COUNCIL MEMBER KING: [off mic] Yes, you
23	have to be ready. (sic)
24	CHAIRPERSON MEALY: I was born ready.
25	[laughter] So I could start?

2 MALE SPEAKER: Yes. 3 CHAIRPERSON MEALY: On this special day 4 this is a very important legislation that we are going to pass today, and we all have to think today 5 is April 4th, and this is the fourth-49th Anniversary 6 7 of Martin Luther King being shot in Memphis, 8 Tennessee. So I hope that we all can pause and 9 remember civil rights sometimes is not civil when people have to lose their life just to do the right 10 11 thing. So I salute Martin Luther King, and I salute 12 this day, and I'm going to turn it over to my 13 colleague, Andy King. He will have some words also 14 in regards to this important day.

15 COUNCIL MEMBER KING: Thank you, Madam 16 Chair, and it's only fitting on a day that one of our 17 greatest civil rights leaders went back to the Lord, 18 that we are here passing legislation voting it out 19 that stands the essence of his existence of fighting 20 for equity, fighting for justice, fighting for all 21 the tings that bring humanity together as opposed to 2.2 dividing us. So, the way we survive is how we feel 23 about our pockets, and when women aren't able to provide for their children, provide for their 24 families in a society that keeps saying that we are 25

2	equal, then it's-it's not fair, and we haven't done
3	right by the people. So, today it's only fitting
4	that the City Council passes a piece of legislation
5	that pulls us all together, that we're able to
6	deliver not only on the financial makeup of our
7	homes, but of our everyday existence. So I'm
8	grateful and thankful to be part of this committee.
9	Grateful and thankful on this historic day. I'm
10	grateful add thank you for Dr. King for the fight
11	that shed light on all the injustices and inequality
12	that happened during the course of American history
13	and the struggle shall continue. Thank you, Madam
14	Chair. [pause]

1 COMMITTEE ON CIVIL RIGHTS 9 2 CHAIRPERSON MEALY: Thank you, Council 3 Member Mathieu Eugene from the Bronx and we have been joined--4 5 COUNCIL MEMBER EUGENE: [off mic] [interposing] I will tell you that. (sic) 6 7 DR. MICHELLE ALLEN: Someday. [laughter] 8 From Brooklyn--9 COUNCIL MEMBER EUGENE: [off mic] [interposing] I don't want to tell her I would like a 10 11 little more than that. (sic) [laughter] 12 COUNCIL MEMBER KING: Thanks for your 13 vigilance. [laughter] 14 CHAIRPERSON MEALY: -- from Brooklyn, and 15 we have another colleague. It's National Equality 16 Pay Day today also. 17 COUNCIL MEMBER CROWLEY: [off mic] That 18 is good. 19 CHAIRPERSON MEALY: And the 49th 20 anniversary or Martin Luther King's assassination. So this is a real civil rights hearing today. My 21 colleague she's not on the committee, but she would 2.2 23 like to have some words on this great legislation, Elizabeth Crowley. 24 25

2 COUNCIL MEMBER CROWLEY: Thank you to our 3 good chair. I'm the lead sponsor in the Council for 4 1253-A, and as the Chair mentioned, today is Equal Pay Day, and while we've made progress, there's still 5 substantial inequality that exists between the wages 6 7 women make versus those of men, and it's a notable 8 size wage gap. And the Census Bureaus says that 9 women in the United States make 79 cents for every dollar paid to men. For women of color, the pay gap 10 11 widens. Black and Hispanic women earn 60 to 55% of 12 the 100% of the dollar respectively, and stretched 13 over a lifetime this disparity leaves women 14 substantially more disadvantaged than the average 15 man. And that's why I'm proud to sponsor that bill that will prohibit employers from asking about 16 17 applicants' salary history. This will reduce the 18 likelihood that women will continue to be 19 discriminated against by prior salary levels. It's 20 fitting that we vote on this during Equal Pay Day, 21 and so again, I-I know that the work that this 2.2 committee is doing will break the cycle of gender pay 23 inequality. Thank you. CHAIRPERSON MEALY: Thank you. 24 Do you

have your--Mr. Mathieu. I think before us, then.

3	I just want to say I want to commend you, Madam
4	Chair, and all the members of this committee and also
5	all the colleagues who have supported this. This is
6	very important. It is a great progress, and we have
7	to continue to fight for the equal pay and let's win
8	so that we're moving toward our goal, and I'm pleased
9	to be one of the co-sponsors of this bill. Thank
10	you. Thank you very much, Madam Chair.
