HIV/AIDS Services Administration Quarterly Performance Report October—December 2016

The HIV/AIDS Services Administration (HASA) is the primary entity within the Human Resources Administration (HRA) to expedite access to essential benefits and social services needed by persons diagnosed with HIV or AIDS and their families. HASA provides:


- Specialized intake and needs assessment;
- Direct linkages to Cash Assistance, Medicaid, Food Stamps, Home Care, and Homemaking;
- Ongoing intensive case management;
- Emergency and non-emergency housing services and placements;
- Voluntary vocational counseling/rehabilitation, job training and placement;
- Assistance with clients' applications for Supplemental Security Income (SSI) and Social Security Disability (SSDI); and,
- Referrals to community-based resources for a variety of additional services.

HASA is committed to service provision that is individualized, efficient, effective and of high quality. The work that HASA performs with its clients is based on the notion that all sectors of the community must work together to ensure that people living with HIV illness have adequate housing, financial security, medical care and other services necessary to allow them to manage the illness and to live their lives with the highest level of self-reliance and dignity.

Local Law 32 of 2005 requires HASA to submit Quarterly Performance Reports (QPRs) to the City Council. The law also requires the QPR to include descriptive statistics, by field operations location, on: the size and demographics of the client population; levels at which financial assistance and social services are requested and granted; time frames for the provision of services; and data on case closings and re-openings. The legislation also requires HASA to report on client utilization of the appeals process, as well as the number of field operations staff, by job title, who directly provide services to clients.

Please see attached QPR compliance report for FY17.2 (October - December 2016). We remain over 90% compliant in issuing approved CBFA grants within 30 days. However, during the first months of the HASA expansion – our compliance rate in issuing approved CBCFAs within 30 days fell slightly from just over 96% to 93.74%. We will work to get this number back over 95%

The average days stay in emergency housing has decrepsed from 152.1 days to 136.9 days. We believe this is owing to increased efforts by staff to move clients out of emergency housing as well as the increase in HASA's rent guideline to match FMR.

We will continue our efforts to ensure that emergency cash assistance and SNAP benefits are issued on the same day requested. However, we are over 90% compliant in both areas.
