The item we will hear is the Lower East side People's Mutual Housing Association tax exemption application; this item, LU 693, is a correction to an application that the Council approved recently pursuant to Article XI of the Private Housing Finance Law. The affected properties are located in the districts of Council Members Chin and Mendez.

We will also be voting on items that were previously heard and laid over; these items: the five remaining POMP applications -- LU 659, 660, 662, 663,

and 666, seeking Article XI tax exemptions for properties that were acquired in rem by the City of New York then disposed of through the Private Owners Management Program. These projects are in the districts of Council Members Gibson, Cabrera, Palma, Torres, and Speak Mark-Viverito.

The amendment to a previously approved UDAAP project and an Article XI tax exemption for the TMN904 Cluster, LU 672; this property is in Council Member Perkins' district.

I am now opening up the public hearing on LU 693, the Lower East Side People's Mutual Housing Association tax exemption application. Please introduce yourself.

JORDAN PRESS: Good afternoon. My name is Jordan Press, Executive Director for Planning and Development in HPD's Government Affairs Unit.

Land Use No. 693 consists of a technical amendment to Resolution No. 1495, approved by the City Council on May 24, 2017. HPD's original submission to the Council inadvertently indicated the legal name of the sponsor to be Lower East Side People's Mutual Housing Association Housing

Development Fund Corporation; however, this entity is
