12	Act, which has provided valuable insight into
13	response times for fire and medical emergency calls.
14	Adding more detail to these reports will only make
15	them even more valuable. Not only would Proposed
16	Intro 135-A require the disclosure of response times
17	all medical emergencies, not just life threatening
18	emergencies, but it would also require the
19	disaggregation of these response times by community
20	district and fire division. All of this data will
21	help both the public and this Council to make more
22	informed decisions on these important issues. I'm
23	proud to sponsor this bill, and I look forward to
24	voting on and passing this legislation today. I'd
