Good 3 afternoon, everyone. 4 SERGEANT-AT-ARMS: Keep it down, please. 5 Quiet down. We're starting the meeting. 6 CHAIRPERSON VAN BRAMER: Good afternoon, 7 everyone, [gavel] and welcome to this convening of 8 the Committee on Cultural Affairs, Libraries, 9 International Intergroup Relations. We have an 10 important oversight hearing on capital construction 11 at our public libraries, but before we do that, 12 seeing quorum, we have an important to take on 13 Resolution No. 792, a resolution establishing January 14 30<sup>th</sup> annually as Fred T. Korematsu Day. We held a 15 hearing on this important issue several weeks ago, and now we are prepared to vote. So, with Council 16 17 Members Cumbo, Rosenthal, Crowley, Koo, and 18 Constantindides all present, we are ready to call the 19 roll on Reso 792. 20 CLERK: Thank you. This is the Committee 21 on Cultural Affairs, Libraries and International 22 Intergroup Relations. Today is December 18, 2017, a 23 roll call vote on Resolution No. 792. We begin with 24 Chair Van Bramer. 25 CHAIRPERSON VAN BRAMER: I vote aye.

2 COUNCIL MEMBER ROSENTHAL: I vote aye and 3 just I would like to align myself with my colleague's 4 comments. Council Member Van Bramer, congratulations and also congratulations to Council Member Dromm, you 5 know, to have a Fred Korematsu Day of civil liberties 6 7 and the Constitution especially in this day and age. 8 This is exactly the right thing to do. He was a true 9 leader and he's finally getting the honor he deserved. This country is a mess, and so I'm glad 10 11 we're honoring him in this way. Thank you. 12 CHAIRPERSON VAN BRAMER: Thank you very

12 much, Council Member Rosenthal. Council Member King, 14 we are voting on Resolution 792 naming January 30<sup>th</sup> 15 as Fred T. Korematsu Day. Would you like to vote on 16 this resolution?

17 COUNCIL MEMBER KING: And I vote aye. 18 CLERK: Thank you, very much, Council 19 Member King and with that, we will-we'll keep the 20 roll open for ten more minutes seeing as other 21 members may want to come and vote while we have our 2.2 hearing, which we will now transition to. We have 23 lots of great folks here from the Department of Design and construction, and others, and we are 24 25 anxious to hear from them on library construction,

Needless to say, I'm 3 enormously proud that in this committee working with 4 the Administration we have increased capital funding 5 for our public libraries. [background comments] Hold on one second. [pause] So, a technical matter. 6 We 7 technically have to close the hearing on the vote, 8 and then re-open the hearing on library capital 9 construction, which I fear means that other members may not be able to vote on this matter. So, with 10 11 that, [gave] we are closing the hearing on Resolution 12 792, which passed obviously and we look forward to 13 passing tomorrow at the Stated Meeting, and then we reconvene our second hearing [gavel] in the last 12 14 15 seconds on Cultural Affairs, Libraries, and International Intergroup Relations. Once again, 16 17 talking oversight-oversight of library capital 18 construction. As I was saying, we have increased [laughs] Okay, great, great. So, that we 19 funding. may be consistent with NYCTV, we're going to pause 20 21 and allow for the Graphics Department to get up the 2.2 right amount of graphics for our new hearing. So, 23 we're going to take a pause until we can actually formally reconvene the second portion of this 24 25 hearing. [end of audio]
