Today we are 6 voting on sexual ant-sexual anti-harassment bills 7 that we heard last month the sexual harassment 8 hearing between this committee and the committee and 9 the Committee on Women chaired by my colleague Helen 10 Rosenthal. I would-I would like to-to thank her for 11 taking the lead on this issue, and I'm proud to 12 support her and the other council members in dealing 13 with this large package of bills, plus I'd like also 14 to thank my colleagues and the committee for their support, Council Member Kallos, Perkins, Rodriguez, 15 16 Lander and Council Member Dromm. Today, we will vote 17 on the following bills: Proposed Intro No. 61-614-A 18 by Council Member Alicka Ampry-Samuel and 19 congratulations, Council Member because I heard this 20 is your first one. Congratulations. 21 COUNCIL MEMBER AMPRY-SAMUEL: Thank you. 2.2 CHAIRPERSON EUGENE: And we are proud of 23 Thank you. 3	Member Keith Powers in relation to expanding sexual
4	harassment protection to all employees.
5	Proposed Intro No. 660-A by Council
6	Member Carlina Rivera in relation to making
7	improvements to clarify and strengthen the human
8	rights law as is related to sexual harassment.
9	Proposed Intro No. 663-A by Council
10	Member Helen Rosenthal in relation to the statute of
11	limitations for filing certain harassment claims
12	arising under the city human right law. Resolution
13	No. 222 by Council Member Daneek Miller, resolution
14	calling upon the United States Congress to pass and
15	the President to sign S2203/H.R.4734, known as the
16	"Ending Forced Arbitration of Sexual Harassment Act
17	of 2017," which prohibits a pre-dispute arbitration
18	agreement from being valid or enforceable if it
19	requires arbitration of a sex discrimination dispute.
20	This package of bills represent a step toward
21	combatting and dismantling the social attitude that
22	has long allowed the perpetrators of sexual
23	harassment to escape consequences. We recognize that
24	there is still much more work to do. In addition,
25	there are grievances of the Me Too Movement. How as

2	that? This are the sexual harassment package. It is
3	an important step and will pave the way toward
4	improvements in how New York City address sexual
5	harassment. I would like-I would like to take this
6	opportunity to thank the Civil and Human Rights
7	Committee staff Becky Norwich, Sheila Johnson, Lydia
8	Scott-Pruitt. (sic) I hope that I pronounced it
9	right, and my staff Adrienne Adams, and Rosie Jovine
10	(sic) for all their work, you know, on this hearing.
11	Before I call the vote, I would like to give the
12	opportunity to my colleagues to make comments on
13	their bills. Who wants to start first? [background
14	comments] Council Member Rosenthal.
15	COUNCIL MEMBER ROSENTHAL: I just
16	appreciate all your work. Thank you very much,
17	Council Member.
18	CHAIRPERSON EUGENE: Okay, thank you and
19	one more time congratulations for your leadership on
20	this very, very important issue. Council Member
21	Kallos, Lander, Rosenthal. No comment? Oh, Council
22	Member, sorry, sorry.
23	COUNCIL MEMBER ALICKA-SAMUEL: Yes, thank
24	you. Thank you Council Member Eugene, Chair of this
25	committee, and the other members of the Committee on

2	Civil and Human Rights. Today, as a member of the
3	Women's Caucus, a wife, a mom, a sister, a daughter,
4	and yet another woman with her own Me Too story. I am
5	proud to sponsor Intro No. 614-A that will require
6	information about sexual harassment be made available
7	online for public access. This bill is quite simple,
8	and just makes sense. It's almost intriguing that
9	such a bill is even necessary in this day and time,
10	but it's the world that we live. We also live in the
11	21 st Century, the digital age and the technology age,
12	and in a time where anything and everything we need
13	is just at our fingertips, and we have to be
14	consistent with the times. When you think about
15	sexual harassment and workplace information, you
16	often think about the office cafeteria or a wall near
17	the water cooler or even bathroom entrances, but
18	could you imagine feeling violated at work then
19	standing next to the water cooler reading
20	instructions about what to do next. It's almost
21	another sense of violation. This process of making
22	information available online in a way is just another
23	sense of being able to feel empowered allowing the
24	individual to take back control of their situation.
25	It also allows for a more discrete way of handling

2	sexual harassment information for those who actually
3	need privacy, and I'm glad to see that the Human
4	Rights Commission is already setting up their
5	initiative enrolling out their digital campaign. So,
6	I want to thank the Speaker, and I want to thank
7	Council Member Rosenthal as well as Council Member
8	Eugene on pushing such an aggressive bill package
9	because, again like I said, it just makes sense
10	today. So, as I look forward to this committee
11	passing this bill package, and then forwarding it on
12	to the full body Council and hopefully being signed
13	into law, we're just doing the right thing that makes
14	sense at the right time. So, thank you again for
15	this opportunity, and let's move forward.
16	CHAIRPERSON EUGENE: Alright. Thank you
17	very much. Thank you. We have been joined also by
18	Council Member Carlina Rivera. I think that when
19	wants to make some comment about her bill.

2	Thank you to Chair Eugene, Committee members, staff
3	and, of course, Speaker Johnson for all of your
4	leadership in response as a Council in the wake of
5	the intense media scrutiny over the violations and
6	sexual misconduct that have always existed but have
7	now come to light. In this city we pride ourselves
8	as being fair progressive leaders, and I introduce
9	this legislation to help us codify legal definitions
10	of and mechanisms to deal with harassment. This bill
11	part of the Stop Sexual Harassment and NYC Act would
12	require that the city of New York amend the Policy
13	Statement of the New York City Human Rights Law to
14	included sexual harassment as a form of
15	discrimination. Take altogether, the full package of
16	legislation strengthens New York City's Anti-Sexual
17	Harassment policies to combat incidents in the
18	workplace. Intro 660 in particular sends a message
19	that address sexual harassment remains at the core of
20	the mission of the Human Rights Commission. In
21	recent months, movements such as Me, Too, and Time's
22	Up have brought forward much needed attention to the
23	issues women continue to face in the workplace
24	throughout various industries. However, this bill
25	will work towards protecting not just women from

2	sexual harassment, but all New Yorkers regardless of
3	gender, sexual orientation or gender identity. By
4	explicitly defining sexual harassment as a form of
5	discrimination under the commission's purview, we are
6	defining person's ability to live free from these
7	incidents as a right in itself. With support around
8	this larger movement for equality, it is this body
9	that must push our city to take responsibility and
10	codify change to serve those who up to now have been
11	too afraid to speak up. I, therefore, urge my
12	colleagues and, of course, thank you for your support
13	on this piece of legislation and the Stop Sexual
14	Harassment package entirely, and I look forward to
15	the subsequent support and speedy implementation by
16	the Administration. Thank you.

18	and again, congratulations. Mr. Clerk, could you
19	please call the roll.
