2 [sound check] [pause] 3 CHAIRPERSON DEUTSCH: You ready? 4 [background comments/laughter] [gavel] Good 5 afternoon. My name is Chaim Deutsch. I'm Chair of 6 the Veterans Committee. I would like to thank you 7 for being here today, and I would like to extend my 8 warmest regards to the veterans who are watching us 9 today on a day after honored their service. In honor 10 of Veterans Day and to honor our veterans and active 11 service members all of whom have sacrificed to 12 protect this great country, the Veterans Committee 13 will be voting on three pieces of legislation this 14 afternoon. These bills are designed-designed to 15 improve the lives of veterans by connecting them to 16 more fully to services that New York City offers 17 resources and benefits that they have earned and that 18 we owe them. I am proud to co-sponsor each of these 19 bills along with Council Member Ulrich. Proposed 20 Intro 391-A would require the Department of Veterans 21 Services, DVS to provide benefits counseling services including offering advice, evaluation information to 2.2 23 veterans and their loved ones who seek assistance 24 with federal, state and city benefits that they may 25 be entitled to because of their service. Counseling

2 services will be provided by trained staff, and will be available in at least one location at each 3 borough. Proposed Intro 394-A would require DVS to 4 establish at least one comprehensive veterans' 5 resource center in each borough by June 1, 2019. 6 7 Each center will be required to be located in the area that is easily accessible to public 8 transportation and for those disabled vets. 9 Each location would provide free current information on a 10 wide range of benefits and options in terms of 11 12 housing, social services and tax exemptions. These 13 centers would be robust with stable weekly hours and offer physical resource guides and benefits 14 15 counseling on the premised as well. DVS would also 16 be required to report on a range of metrics pertaining to these certain-to these centers starting 17 18 in January of 2020 to make sure they are serving our veterans properly. Finally, Proposed Intro 396-A. 19 20 It would require DVS to maintain and regularly update a resource quide for veterans. This quide would be 21 available on the DVS website in written format. 2.2 Τf 23 requested-if requested, it would contain information about a wide range of veteran specific opportunities 24 programs, services, organizations and benefits in 25

2	both the public and private sector, and Eric is not

4	Although we can never fully repay veterans for the
5	service that they rendered, we can and must do all we
6	can to support them and continue supporting them as
7	they transition back to civilian life. It is my hope
8	that today's legislation will just do that. I
9	believe these bills will help us serve our city's
10	veterans population better and I urge the Committee
11	members to vote in favor of these bills. We'll open
12	the-call for the Clerk.
