CHAIRPERSON CABRERA: Welcome to the second hearing and vote of the Committee on Governmental Operations. I am Council Member Fernando Cabrera, Chair of the Committee on Governmental Operations. Today, we are holding a second hearing and a vote on the following bills regarding the voting rights of justice involved Introduction 367 sponsored by Council persons. Member Salamanca in relation to the Department of Probation informing persons of their voting rights, and Introduction 1115-A sponsored by myself in relation to agencies assisting eligible parolees with voter registration. There's a tremendous amount of confusion on when a justice involved person can vote. Our goal with the two bills to be voted out of the committee today is to provide as much education and clarity as possible to justice involved individuals. To that end, I would like to clarify that a justice involved person only loses his right or her right to vote when he or her is convicted of a felony. Anyone convicted of a misdemeanor of which charged with a felony, but still waiting trial, we change their right to vote. Anyone on probation can still vote.

Before this year, a person on parole could not vote and the right to vote was only restored after they completed their parole. However, in April of 2018 the Governor issued an executive order that created a process for granting conditional pardons that restored only the right to vote to parolees. Now-so now, some, but not all parolees can vote. This is a wonderful step forward. However, for it to work, we are to need to do a tremendous amount of public education. Introduction 367 sponsored by Council Member Salamanca requires the Department of Probation distribute written notice on the voting rights of the person sentenced to probation during their intake process. Now, on bill Introduction 1115-A approaches this issue by ensuring that the staff of the agencies covered by the Agency Based Voter Registration Law, which require agencies to assist the public in voter registration are provided with guidance on the voting rights or formerly incarcerated persons. guidance is to be developed by the Voter Assistance Advisory Committee. The bill will also require agencies covered by the law upon request by a formerly incarcerated person to check if they are eligible to register to vote. I want to thank the

Director Claire Michael Bain for all of their work,
and with that let me give the floor to Council Member

Salamanca, and I want to commend you to on your bill.

COUNCIL MEMBER SALAMANCA: Thank you, Chair Cabrera. Good afternoon everyone, and thank you all for allowing me to speak on my bill. I want to encourage my colleagues to vote yes on Intro 367, which would require the Department of Probation to inform people on probation of their voting rights. The issue of mass incarceration in our nation largely affects our black and brown communities, and with their pervasive misinformation of who can't and can vote, it is up to us to educate an improve voter turnout. Communities of color like the one I represent feel this heavy burden. I believe that creating or instilling a sense of civic efficiency can begin at a very basic level. Integrating back into a community can being with feeling like you have a voice, and in this case, casting a vote can be that voice. We should be encouraging participation in
