4	2018. This is the Committee on Civil Rights and
5	Human Rights being recorded by McKinley Joseph.
6	CHAIR MATHIEU EUGENE: (Gavel pounding).
7	Good morning. My name is Council Member Matheiu
8	Eugene and I am the Chair of the Civil and Human
9	Rights Committee. Today our Committee will be voting
10	on Introductory Bill 863A which will amend an
11	Administrative Code to prohibit employee
12	discrimination based on individual's reproductive
13	health choices. This Bill aims to make a number of
14	changes, the first is 863A with expand the lease of
15	protected classes that are essential in reproductive
16	health decisions to the lease. Section 2 of the Bill
17	will explain the definition of sexual and
18	reproductive health decision. Under the Section
19	number bill, such a decision would be class as any
20	decision by the operee to receive services which are
21	a range of full, offered or provided to individuals
22	relating to the reproductive system and its functions
23	including but not limited to fertility related
24	medical procedures, family planning services and
25	counseling, including but not limited to access to

2	all medically approved birth control drugs and
3	supplies, emergency contraception, sterilization
4	procedures, pregnancy tested, sexually transmitted
5	disease testing and treatment, abortion procedures
6	and HIV testing and counseling. By adding sexual and
7	reproduction health decision to the list of protected
8	categories this Bill aims to make it unlawful for
9	employers to discriminate against the workers on
10	sexual and reproductive health choices. Before we
11	vote, I would like to thank, well let me first uhm
12	acknowledge the Council Members who are here.

Uhm 12 reproductive health is something that is a basic 13 right for anyone and as the rest of the country falls 14 apart, New York City can stand strong and know that 15 we are codifying a woman's reproductive rights and 16 health into our uhm Human Rights Laws and I want to 17 thank Council Member Jumaane Williams for carrying 18 this Bill. I vote aye.
