CHAIRPERSON BORELLI: There is Cabrera and Deutsch. We are here today to vote on legislation related to the posting of hurricane evacuations in multiple dwellings. This is Proposed—Proposed Intro 562-A sponsored by Council Member Mark Treyger requires that the owners of multiple dwelling buildings post notice in common areas listing information of the building's designated evacuation zone and relevant information to determine the location of the nearest evacuation centers. As an aside, we certainly saw this problem realized in 2012 with Superstorm Sandy. As the city prepares for the summer and autumn months where many of our communities are at risk of flooding from coastal storms, this information will help raise awareness of the risk posed by hurricanes and inform residents on how to determine where they can seek safety in case of evacuation. I would now-I do not see the sponsor so we will begin the voting immediately.
