3	Chambers could come to order. At this time I'd
4	like to ask if all cell phones could be either
5	turned off or moved to vibration mode, and that
6	all private conversations please happen outside of
7	the Committee room. Good morning. My name is
8	Eric Martin Dilan, and I'm the Chairperson of the
9	City Council's Housing and Buildings Committee,
10	and today the Committee will be considering for
11	the purposes of a vote, Proposed Intro 874-A,
12	which is a local law in relation to methane and
13	radon gas vent piping, the approval of mechanical
14	joint piping systems and the approval of non-code
15	prescribed drainage vent systems. The Council was
16	obviously concerned about the release, when it
17	does happen, of methane and radon gas from
18	underground areas and into the atmosphere during
19	construction. And this bill is intended to allow
20	for new, for the introduction of new methods of
21	ventilation into the marketplace. The bill was
22	amended from the original version as described on
23	page five in the Committee report for the benefit
24	of the members. For the benefit of the public,
25	the amendments are: requirement the Department of

2	Buildings to establish the acceptance criteria for
3	the installation of mechanical joints; deleting a
4	requirement that computer designed, engineered
5	vent systems comply with the administrative code,
6	and be approved by the Commissioner as this is
7	already required by the plumbing code. It makes
8	several technical corrections throughout the bill,
9	and the changing of the effective date from 90
10	days to 180 days. And I, before I ask the clerk
11	to call the roll, we're joined by the bill's
12	sponsor, Council Member Inez Dickens. I'd like to
13	acknowledge her to make a brief statement.
14	COUNCIL MEMBER DICKENS: Thank you,
15	Chair Dilan, for allowing me to provide testimony
16	in support of Intro 874. With the support of the
17	Plumbers Union, at your October 15 th hearing, which
18	I was unable to attend due to a family member's
19	funereal, I asked the Chair's permission and was
20	granted such, to submit my written testimony
21	setting forth the reason that make this
22	legislation necessary and important, and ask for
23	your support. Therefore, I won't take the
24	Committee's time to reread my submitted testimony,
25	but I am here to answer any questions, and I do
