3 CHAIRPERSON MATTEO: [gavel] Good morning 4 I'm Steven Matteo. I'm Chair of the everyone. 5 Standards and Ethics Committee. I'm joined by my 6 colleagues Karen Koslowitz and Margaret Chin. The 7 Committee on Standards and Ethics is meeting today 8 regarding disciplinary matter open pursuant to 9 Section 10.80 of the Council Rules concerning Council 10 Member Andy King. Because it is necessary for the 11 committee to discuss confidential personnel issues, 12 I'll make a motion for the committee to move into 13 executive session pursuant to Article 7 of the Public 14 Officers Law. Do I have a second? 15 COUNCIL MEMBER CHIN: Second 16 CHAIRPERSON MATTEO: Recognizing a second 17 from Council Member Chin, a motion has been made and 18 seconded that the committee move into executive 19 session. Al those in favor of this motion say aye. 20 COUNCIL MEMBERS: (in unison) Aye. 21 CHAIRPERSON MATTEO: Noting that the ayes 22 have it, I'm not going to close this portion of the 23 meeting and reopen in executive session. We are also 24 joined by Council Member Gibson. Before we proceed 25 into executive session, I will note for the public

2	that the committee may vote on certain items of
3	business during this session, and as a result, there
4	may be an additional open session of the committee
5	later today. Thank you. [gavel] [pause] [gavel]
6	Okay, everyone, thank you for your patience. Again,
7	I'm Steven Matteo. I'm Chair of the Standards and
8	Ethics Committee. I'm joined by my colleagues Steve
9	Levin, Karen Koslowitz, Vanessa Gibson and Margaret
10	Chin, and also Ben Smith committee counsel and our
11	General Counsel Nope. Oh, I'm sorry, no, the General
12	Counsel is Jim Caras. The committee is now returning
13	to open session to make public the outcome of today's
14	vote. Today the Committee on Standards and Ethics
15	found the changes against Council Member King to have
16	been substantiated and is recommending sanctions and
17	corrective actions to the full Council. As you may
18	recall, the four charges were: Retaliation under the
19	Council's EEO Policy, disorderly conduct, conflict of
20	interest and violations of Council Rules and the City
21	Charter and harassment under the city's-the Council's
22	EEO policy. Under the City Charter the Council is the
23	judge of the qualifications and conduct of its own
24	members, and pursuant to Council Rules, the Standards
25	and Ethics Committee may find that a member has

2 engaged in disorderly conduct and upon adoption 3 report outlining its evidence may recommend sanctions to the full Council. The committee voted today to 4 transmit the report to Council King's attorneys to 5 the full Council later today. Please note that the 6 7 report will also be made public available by close of business tomorrow. The committee also voted today to 8 authorize staff to make any and all appropriate 9 referral-referrals of this matter. We expect the 10 full Council to meet to consider our findings and 11 12 recommend the sanctions early next week. We do not 13 take this duty lightly, and this is a very serious 14 matter. I had to start by noting that this is 15 Council Member King's second substantiated complaint 16 before the committee. In 2017, Council Member King 17 was found to have violated the Council's EEO Policy 18 and required to complete mandatory training. Less than two years later, we received a communication 19 20 from the City's Department of Citywide Administrative Services that a former staffer of Council Member King 21 2.2 had been denied unemployment benefits by the 23 Department of Labor, and had appealed that denial by claiming that the staffer had been constructively 24 25 fired due to gender base harassment on the part of

2	Council Member King. It was this finding by a state
3	agency that led to the current discipline-
4	investigation. We began the subject investigation
5	into these allegations in March of 2019. Although
6	the committee was ultimately unable to fully
7	investigate the gender-based harassment allegations
8	made by the former Council staffer, in part because
9	the staffer at some point declined to participate
10	further in the investigation. During interviews,
11	allegation after allegation, and problem after
12	problem surfaced in the function of Council Member
13	King's Office. Perhaps one of the most disturbing
14	allegations, which the committee found substantiated,
15	was that in 2017 Council Member King in an effort to
16	obstruct the first investigation in 2017 held a staff
17	meeting in his home where he-he identified the 2017
18	complainant by name and disparaged the complainant to
19	his entire staff. This is behavior that cannot be
20	tolerated. The evidence also clearly demonstrated
21	that with regard to the current investigation,
22	Council Member King repeatedly intimidated and
23	punished staff who asked would-would cooperate with
24	the committee's investigation. He demanded that
25	staffers who have cooperated with us admit their

2 cooperation to him. Of the three staffers who 3 admitted they had cooperated, one was driving out of 4 his office, he attempted to fire another and the 5 third must have clearly gotten the message because 6 even a subpoena wasn't enough to compel that 7 staffer's cooperation. In addition, he attempted to fire another staffer who had witnessed much of this 8 conduct, and who ultimately testified at our hearing. 9 The evidence also clearly demonstrated that Council 10 Member King allowed his office to become unsafe and 11 12 disorderly by condoning the conduct of a supervisor 13 who repeatedly physically threatened persons in the 14 It is also clear that Council Member King office. 15 facilitated numerous conflicts of interest in the office that benefit both himself and his wife. 16 All 17 this will be outlined in our report to the Council. 18 The truth is were it not for Council Member King's behavior during the pendency of this investigation, 19 we would probably not be discussions sanctions of the 20 magnitude contained in our recommendations including, 21 2.2 but not limited to a suspension, a significant 23 monetary penalty, removal from all committee 24 assignments, and a permanent monitor in his office for the duration of his term. Council Member King 25

2	was aware of the investigation into his conduct from
3	the time the committee opened it on March 13, 2019.
4	He was offered the opportunity to engage with the
5	committee and was also advised to retain counsel to
6	protect his interest during such engagement.
7	However, and the outset, the Council Member adamantly
8	refused to cooperate. He refused many overtures from
9	both the committee and the Special Council, and never
10	once appeared for an interview with either Committee
11	Investigationinvestigators or the Special Counsel
12	except for one brief conversation to defend the
13	supervisor in his office accused of threatening and
14	intimating behavior. During that conversation, he
15	never once denied that any of that supervisor's
16	behavior had occurred and, in fact, seemed to condone
17	it. Indeed, instead of cooperating, Council Member
18	King attempted to make a mockery of this committee
19	and the Council's rules and policies. His attorneys
20	are arguing that he did not have enough time to
21	adequately respond to the charges against him. While
22	the original charges were filed and sent to him on
23	August $21^{st}$ and the hearing began on September $13^{th}$ .
24	That is over three weeks. The reason there were
25	superseding charges file on September $4^{th}$ was that

2	instead of preparing for the hearing, Council Member
3	King appears to have spent that period suspending or
4	attempting to fire his staffers who were cooperating
5	or potentially could cooperate with our
6	investigation. While the Committee certainly would
7	have been inclined under normal circumstances to
8	consider a reasonable adjournment, we were not going
9	to give Council Member King more time to hurt
10	staffers who done-done nothing more than carry out
11	their obligations to the Council to cooperate, and
12	were not going to let him undermine those committees
13	and the Council's authority and obligation to judge
14	the Conduct of its members. We followed the
15	committee's disciplinary procedures and provided
16	Council Member King's attorneys with copies. We held
17	a hearing in which the committee heard from
18	witnesses, and provided Council Member King the
19	opportunity to present his own witnesses and
20	evidence. Council Member King failed to appear for-
21	appear at the hearing, and his attorneys only
22	appeared to object to the very fact that a hearing
23	was taking place. They then got up and left. The
24	witnesses were credible and damning. In general,
25	they support each other's testimony, and there were

2	documents that also supported many of the charges.
3	The committee was unanimous in its determination that
4	the four charges had been substantiated by a
5	preponderance of the evidence. Finally, I would like
6	to reiterate that redacted copy of the Committee's
7	full report will be made publicly available tomorrow
8	after it's transmission to the Council Members. This
9	report will contain the proposed recommended
10	sanctions as well. We are timing the public release
11	of the report to our members to fully review our
12	findings and recommended sanctions. As stated
13	earlier, we expect the full Council to meet to
14	consider our report and recommended sanctions early
15	next week. Thank you all for your time, and we are
16	adjourning the meeting. Thank you. [gavel]
