FISCAL IMPACT STATEMENT

**COMMITTEE:** Environmental Protection

**TITLE:** A Local Law to amend the administrative code of the city of New York, in relation to upgrading lighting systems and the installation of sub-meters in buildings greater than 50,000 gross square feet.

**SUMMARY OF LEGISLATION:** The legislation will require buildings that exceed 50,000 square feet or 100,000 square feet if two buildings are on the same tax lot, to upgrade lighting systems bringing them in line with requirements for new systems. The legislation applies to both private and City owned properties. It is estimated by the Department of Citywide Administrative Services (DCAS) that the additional cost to the City for upgrades to its properties will be \$3.50 per square foot, with an estimated 4.3 million square feet of lighting upgrades per year, bringing the estimated additional cost per year to approximately \$15,000,000. The lighting upgrades are forecast to pay for themselves with energy savings in an eighteen to twenty four month time frame.

The legislation also mandates that sub-meters be installed in tenant space larger than 10,000 gross square feet on one or more floors of a building fitting the above description which is let or sublet to the same person, or a floor of a building larger than 5,000 gross square feet consisting of one or more tenant spaces let or sublet to one person or to two or more different persons. The property owners will be responsible for the installation of the sub-meters which are estimated to cost \$5,000 per meter installed. The City in the majority of cases is the sole tenant of any properties it owns and in the situations where there are tenants a sub-meter is usually present, making the added cost to the City minimal. Each tenant renting space with a sub-meter monitoring its energy usage shall receive a monthly report detailing its energy consumption.

**EFFECTIVE DATE:** This law shall take effect immediately.
