FISCAL IMPACT STATEMENT

**INTRO. No:** 1083-A

**COMMITTEE:** Parks and Recreation

**TITLE:** To amend the administrative code of the City of New York, in relation to requiring local representation on park conservancies.

**Sponsor:** By Council Members Mark-Viverito, Avella, Jackson, Barron, Dickens, James, Koppell, Lappin, Liu, White Jr., Palma, Sanders Jr., Seabrook, Nelson, Foster, Ferreras, Vann, Mendez and Sears

SUMMARY OF LEGISLATION: This legislation would require that for any park conservancy arrangement, at least one local representative, meaning an individual who resides in or has a place of business in the council district where the park is located or abuts, be a voting member of the board of directors of the conservancy. The local representative would be designated in a manner determined by the Department of Parks and Recreation in consultation with the council members representing the districts in which the park is located provided that each local representative is designated not less than thirty days following its initial consultation with the appropriate council member. If a park is located in or adjacent to more than one council district, there would be no more than one local representative from each council district in which the park is located and no more than one local representative from two of the council districts abutting the park. In the event that local representatives would be greater than twenty percent of the appointed membership of the conservancy's board of directors or there are more than two council districts abutting a park, the department would determine which council districts would be represented initially, in consultation with the relevant council members, and local representatives would thereafter be rotated in a manner determined by the department.

**EFFECTIVE DATE:** This local law shall take effect immediately upon enactment.
