Welcome to the remote hearing to the 10 Committee on Housing and Buildings. Will council 11 members and staff please turn on their videos at this 12 time? Again, will council members and staff please 13 turn on their videos at this time? To minimize 14 disruptions, please place all cell phones and 15 electronic devices on vibrate? Chair, we are ready 16 to begin. 17 CHAIRPERSON CORNEGY: Thank you. Good 18 morning, everyone. Thank you for coming. I Council 19 member Robert Cornegy, Chair of the Councils 20 Committee on Housing and Buildings. We're here to 21 vote on a bill related to incorporating the use of 22 drones into the important process of conducting 23 building façade inspections. Required by law since 24 1980 and enforced by the Department of Buildings, 25 periodic building façade inspections are intended to

2	ensure that building facades are safe and secure,
3	mitigating the risks of bricks and debris falling
4	onto pedestrians below. However, despite these
5	inspection requirements, accidents still happen and
6	can have tragic consequences. The use of drones may
7	enable more thorough façade inspections and improve
8	pedestrian safety. Further, they may reduce the need
9	for sidewalk sheds which are often installed for the
10	purpose of conducting façade inspections and repairs.
11	However, there are many questions regarding the
12	safety and feasibility of allowing drones to conduct
13	façade inspections such as potential conflicts with
14	federal rules and issues related to privacy. To
15	answer these questions and to facilitate the
16	implementation of drone technology, proposed intro
17	number 1853A, which I sponsored, would require DOB to
18	conduct the study of the safety and feasibility of
19	allowing drones to conduct façade inspections. I am
20	joined today by committee members Louis, Perkins,
21	Rosenthal, Cabrera, and Yeger. Oh, and I see Council
22	member Gjonaj, also, has joined. Did I miss anybody?
23	We will now ask the committee clerk to call the role.
24	Oh. I see Barry Grodenchik. I'm sorry. Hey, Barry.
25	COUNCIL MEMBER CHIN: And me, Robert.

11	Introduction 1853a. Chair Cornegy?
12	CHAIRPERSON CORNEGY: I would like to
13	explain my vote, please. So, good afternoon. 1853A
14	takes a step forward in a longer process of updating
15	our laws to reflect technology we have available
16	today. Drones can play a positive role in building
17	management, from façade and roof inspections to
18	energy efficiency analysis. Drones can offer cost-
19	effective opportunities to detect problems early and
20	prevent tragic injuries and deaths. The current 22-
21	year-old and 72-year-old local laws that govern drone
22	use are due for a fresh look by all of us as
23	policymakers. As we pursue this first step studying
24	drone laws and regulations and offering
25	recommendations for changes, intro 1853A recognizes

2	the need to include safety and privacy protections in
3	our analysis. We want to pursue any changes with an
4	awareness of perspective from multiple stakeholders
5	and take their insight and expertise on board. I
6	want to thank my colleagues and I especially want to
7	thank all of the experts and advocates who have
8	already begun to share their expertise and experience
9	with us. This legislation and the report it requires
10	that the Department of Buildings to produce will help
11	us bring façade inspections and our broader drone
12	policies up to date. Ultimately, that means more
13	competence in the safety of our buildings and more
14	safety for every day New Yorkers. All New Yorkers
15	and the legacies of Grace Gold, Erica Tishman, Xang
16	Yi, and all those killed or injured due to building
17	façades deserve no less. And, with that, I vote aye.
