3	morning, my name is Karen Koslowitz and I am the
4	new Chair of the Committee on Consumer Affairs.
5	Today the committee will be voting on Proposed
6	Introductory bill number 5-A, a Local Law to amend
7	the Administrative Code of the City of New York in
8	relation to disclosure of the use of tenant
9	screening reports.
10	As you may know, a tenant screening
11	report is a consumer report used by landlords that
12	lists Housing Court cases filed against a
13	particular individual. Many landlords use these
14	reports to evaluate the fitness of a prospective
15	tenant. Unfortunately, information in the report
16	may be incomplete, inaccurate, or wholly
17	erroneous, and can be used to deny people housing.
18	Intro 5-A would ensure that consumers are aware of
19	the existence of tenant screening reports and
20	would assist them in obtaining copies of their
21	reports. It would also require all landlords and
22	management companies to disclose in writing, A,
23	whether or not they use tenant screening reports,
24	and, B, the name and address of the screening
25	agency used if they do not use tenant screening

2	reports. [Pause] And, C, the fact that consumers
3	are entitled to one free copy of their tenant
4	screening report per year.
5	I would like to call on Council
6	Member Garodnick, who sponsored this bill, to say
7	a few words.
8	COUNCIL MEMBER GARODNICK: Thank
9	you very much, Madam Chair, and thanks to the
10	entire Consumer Affairs Committee for taking up
11	the Tenant Fair Chance Act. We have now of course
12	had testimony over two hearings which has further
13	demonstrated the need for clarity and a proper
14	notification to tenants of the laws. While there
15	exist federal and state laws that require a
16	disclosure of tenant screening reports,
17	prospective tenants are usually not aware that
18	these reports exist or that they're used at all
19	and, therefore, don't ask to see them. This law
20	will alert tenants to the existence of these
21	reports and will enable them to take back control
22	of their own rental histories.
23	This legislation, I believe, will
24	add a measure of clarity to the reports and will
25	give prospective renters a chance to correct and

2	amend information about their tenancy and their
3	background.
4	This bill, as you noted, Madam
5	Chair, will require any landlord, management
6	company, or broker who uses a tenant screening
7	report to disclose the name of the agency that's
8	providing a copy of the report that enables a
9	tenant to dispute inaccuracies directly with the
10	agency. All users of the reports will also be
11	required to post a sign telling tenants that under
12	federal law they're entitled to copies of these
13	reports from each tenant screening agency.
14	As a result, I believe the tenants
15	are not going to be held hostage by their past,
16	they're not going to suffer because they asserted
17	rights in Housing Court or because they share a
18	popular name. It is time for tenants to be fully
19	aware of these reports and have the opportunity
20	and the power to change them. So, with that,
21	Madam Chair, I thank you again and I encourage my
22	colleagues who serve on this committee to vote yes
23	in favor of this legislation, Proposed Intro 5-A
24	today.
25	CHAIRPERSON KOSLOWITZ: And I would

3	coming before this committee to help the consumer.
4	Thank you very much.
5	With that, we'll have the roll

12	WILLIAM MARTIN: Updated vote on
13	Consumer Affairs is now six in the affirmative,
14	zero in the negative, no abstentions. [Pause]

17	WILLIAM MARTIN: Final vote on the
18	Committee on Consumer Affairs now stands at seven
19	in the affirmative, zero in the negative, and no
20	abstentions. Thank you.
